**ORDER**

Government of Goa in consultation with the Ld. 2. The allotment of cases before the Hon'ble Supreme Court of India for defending the interest of Government of Goa will be made by the Ld. Advocate General of the State of Goa.
3. The Standing Counsels has to keep the Ld. Advocate General of the State of Goa informed well in advance of the date of hearing of the matters and also seek his instructions from time to time.
4. No Counsels other than above shall be engaged, unless approved in prior point of time; else the Ld. Advocate General of the State of Goa shall appear in Hon'ble Supreme Court of India in the all matters of Supreme Court of India.
5. The Standing Counsel shall be paid ₹. 5,500/- (*Five Thousand Five Hundred Only*) per effective appearance before the Hon'ble Supreme Court of India, New Delhi, National Green Tribunal, New Delhi and other Courts including JERC Gurgao, High Court of Delhi and other Tribunals and also they shall be entitled to a fee of ₹. 1,000/- (*Rupees One Thousand Only*) for every drafting of Affidavit or Special Leave Petition. In addition to this, they shall be entitled for reimbursement of an amount of ₹. 2,500/- (*Maximum*) (*Rupees Two Thousand Five Hundred Only*) per month towards Miscellaneous expenses such as stationery, purchase of papers photo copying of documents, pleading, case extracts/citations etc. subject to production of necessary bills/cash memos/ receipts duly certified by respective Standing Counsel as per the Order dated 31/07/2014.
