

## **SCHEMES UNDER GOA LABOUR WELFARE BOARD**

The Goa Labour Welfare Board has extended various Schemes, Assistants/benefits to the industrial workers in Goa for the year 2017-2018.

Those workers who have been put in more than 6 months continuous service and whose pay does not exceed Rs. 20,000/- per month are eligible to avail the benefits of these schemes.

The last date for submission of applications is September 30, 2017 for schemes such as Grant of Financial Assistance for purchase of text books /note books to school going children of Industrial Workers /Employees, Grant of Financial Assistance to school going children of workers /employees studying in 1<sup>st</sup> to 4<sup>th</sup> standards for supply of one set of uniform, Award of Scholarship to school or college children of workers employees in various establishments, Scheme to Pay incentive to the wards of workers on the basis of percentage of marks obtained by them passing final examination conducted by the Board/Universities from class X onwards and Scheme to provide Incentive/Financial Assistance on the basis of attendance in School/College etc. to the female students studying in class V and onwards in any field of education being daughters of workers/employees

There is no time limit for submission of applications for schemes such as Scheme for supply of T. V. Sets to Industrial Establishments /Labour Welfare Centres /Clubs /Recreation Rooms, Scheme for Grant of Financial Assistance to the Industrial Worker/Employee for purchase Spectacles, Scheme for Treatment of Mentally Challenged and Spastic Children of Industrial Workers, Scheme for Grant-in-Aid to Libraries from Goa Labour and Scheme to grant financial assistance to laid off Workman, Scheme for the benefits of children of Industrial Workers/Employees(Labour Welfare Centres) and Scheme for Organising Sports Games Social and Cultural Activities for Industrial Workers/ Employees, Scheme for Excursion-Cum-Study Tours For the Workers/Employees employed various industrial Establishments and Creches - Scheme for the Benefit of children of industrial Workers/Employees.

The last date for submission of applications is 6 months from date of delivery for Child care benefits for female industrial workers, The last date for submission of applications is one year from Date of operation for schemes such as Scheme for payment of extra monetary compensation for sterilization to employees and Scheme for T.B. Domiciliary Treatment of Employees covered under the Goa Labour Welfare Act,1986.

The last date for submission of applications is within one year from the date of Retrenchment or within 6 months from the date of settlement for Retrenched Workers Assistance Scheme.
