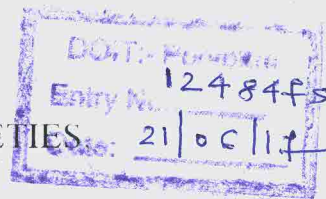

Societies, Government of Goa, 'Sahakar Sankul', 4<sup>th</sup> floor, EDC complex, Patto, Panaji on the same date at 04.00 p.m. during which period the tenderers or their authorized representatives may remain present. Tender catalogue alongwith terms and conditions can be obtained from the same office on all working days/hrs, on payment of Rs. 100/- (non refundable) per set from 19/06/2017 to 27/06/2017 (upto 4.00 p.m.).

Vehicle shall be available for inspection from 19/06/2017 to 27/06/2017 (upto 4.00 p.m.) as per the details of locations mentioned in the tender catalogue.

(a) E.M.D. will be at the rate of 25% of the quoted bid value of the vehicle in case of disposal. The same shall be in the form of D.D./Pay Order of any Scheduled Bank drawn in favour of the Registrar of Coop. Societies, Secretariat Branch Panaji Goa payable at Panaji – Goa and to be enclosed in sealed envelope by all bidders alongwith their offer.

(b) The balance 75% of highest bid value of the vehicle should be paid by the bidder within 7 days from the date of issue of sale letter/acceptance letter by the Department to the successful bidder. This balance payment shall also be in the form of Pay Order/D.D. of any Scheduled Bank drawn in favour of the Registrar of Coop. Societies, Secretariat Branch Goa, payable at Panaji. In case of failure to make balance payment in time the amount deposited as per clause (a) above shall stand forfeited.
