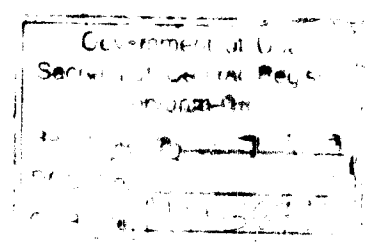


**Key functions of Executive Committee:**
