CIRCULAR

The Election Commission of India, New Delhi has fixed the Special summary revision of Photo Electoral Rolls with reference to 01/01/2018 as qualifying date.


The programme for final publication of the Photo Electoral roll is as detailed below:

Sr. No.	Stages of Revision	Period allowed for each stage
1.	Draft publication of Rolls	18-09-2017 (Monday)
2.	Period for filling of claims and objections	18-09-2017 (Monday) to 17-10-2017 (Tuesday)
3.	Reading of relevant part/selection of Photo electoral rolls in Gram Sabha/Local Bodies and RWA meetings, etc & verification of names.	19-09-2017(Tuesday) and 31-10-2017(Tuesday)
4.	Special campaign dates with Booth level Agents of political parties for receiving claims and objections	24-09-2017 (Sunday) and 08-10-2017 (Sunday)
5.	Disposal of claims and objections	By 17-11-2017 (Friday)
6.	Updating the database, merging of photographs, updating Control Tables and preparation and printing of Supplementary list	16-12-2017 (Saturday)
7.	Final publication of Electoral Rolls on	08-01-2018 (Monday)

As per the standing instructions from the Election Commission of India, no officers/officials connected with the exercise of revision of electoral rolls like the District Election Officers, Deputy District Election Officers, the Electoral Registration Officers/ Deputy Collectors/ Chief Officers and the Assistant Electoral Registration Officers/ Mamlatdars/ Joint Mamlatdars/Block Development Officers of Goa State, should be transferred from their places of posting without the prior concurrence of the Election Commission of India, right from the commencement of the summary revision work till its completion and the vacant posts, if any, related with the work of the Revision of the electoral rolls is required to be filled immediately.

Therefore, all Heads of Departments are required to extend full co-operation to the Electoral Registration Officers involved in the process of revision of Electoral Rolls and ensure that the leave, if any, applied for by the Officers/ Officials connected with the revision of electoral rolls, is granted with due care and scrutiny so that the work of revision of electoral rolls does not suffer.
