

## TERMS AND CONDITIONS

- 1) The Work shall be governed by the agreement under PWD Form 8
- 2) You have to pay an amount of Rs. 6,912/- towards earnest money deposit by Demand Draft drawn from any schedule Bank guaranteed by Reserve Bank of India payable at Margao In favor of The Executive engineer Elect dept Div no XIV Verna. The quotation received without EMD in a separate envelope will be rejected. The government shall without prejudice to any other right or remedy, be at liberty to forfeit 50% of the EMD ,if any quotationer, whose quotation is accepted fails to commence the work specified in the work order within the prescribed time or abandons the work before its completion.
- 3) Security deposit amounting to 5% of the ordered value will have to be paid by you or same shall be deducted from the bills after adjusting the EMD paid by you. Security deposit will be retained till the hiring period of the vehicle is complete and thereafter it shall be released at the satisfaction of the Engineer in charge.
- 4) Payment will be done monthly basis subject to acceptance to work by the Engineer in charge .Contractor shall indicate income tax, Pan number and Tin number registered with the Collectorate of Custom & Central sales tax in the Invoices/receipt, Bank account no., Name of the bank, IFSC code, MICR code, mobile no., email address for e-payments without which payments will not be released.
- 5) In case of failure to complete the work within the schedule due date, compensation of 1% of the order value per day of delay in completing the Work beyond scheduled due date, but not exceeding 10% of the order value will be levied.
- 6) Valid Income Tax Clearance Certificate shall be furnished along with the offer.
