CIRCULAR

Sub:- Implementation of the revised pay structure vis-à-vis the recommendations of 7th Pay Commission (as adopted by Government of Goa to its employees), to the employees functioning in Autonomous Bodies & Agencies/Corporations/ Public Sector Enterprises (PSE's)...reg.

Various requests have been made by the employees of the State Government PSE's/Corporations/Autonomous Bodies & Agencies, to the State Government, for implementing the revised pay structure (as per 7th Pay Commission recommendation) which has been made applicable to the employees of the Government and Government Aided Educational Institutions vide O.M. No.8/1/2016-Fin(R&C)/(A) dated 30/11/2016. The last revision in pay structure of the PSE's/Corporations/Autonomous Bodies & Agencies was undertaken in the year 2010 vide O.M. of even number dated 27/01/2010 (as amended from time to time) read above.

- 2. This matter was under active consideration of the Government for sometime now and Government has decided to consider implementation of the revised pay structure vis-à-vis the recommendations of 7th Pay Commission (as adopted by Government to its employees), to the employees functioning in PSE's/Corporations/Autonomous Bodies and Agencies, on case-to-case basis, subject to the following conditions:—

concerned, so as to make up for the gap in incurring payments of the revised pay structure to its employees and meeting other recurring liabilities on this account.

- (ii) The Management/Board of Directors of the PSE's/ Corporations/ Autonomous Bodies and Agencies concerned, shall take into account all the relevant factors pertaining to the functioning of the Organization and accordingly take the decision to recommend the implementation of the revised pay structure not exceeding that prescribed for the Government to its employees.

 - (a) The activities being conducted by the Organization,
 - **(b)**Additional revenue generation measures to meet the liability for payment of the revised pay structure, and
 - (c) the staffing strength of the said Organization.

The recommendations shall be submitted to the Government and after obtaining administrative approval, the proposal shall be submitted to the Finance Department for further analysis and final approval.

- (iv) Administrative Departments are advised that no recommendations for implementing revised pay structure shall be received by the Finance Department, in the event the staff and employees of the PSE's/ Corporations/ Autonomous Bodies and Agencies concerned, have resorted for wage dispute redressal or any other redressal before the Office of the Labour Commissioner or any other Court of Law, under the provisions of the Industrial Dispute Act, 1947 or the Workmen's Compensation Act, 1923 or any other law in force.
 - 3. All PSE's/ Corporations/Autonomous Bodies and Agencies shall strictly adhere to the above directives and submit the proposal to Government and consequently to Finance Department before 31/01/2018.
 - All PSE's/ Corporations/Autonomous Bodies and Agencies shall note that merely issuance of this Circular, does not imply or should not be construed as
