C I R C U L A R

Subject:- Supply of dietary and non-dietary items to Government Departments/Institutions, reg.

In supersession of all the Circulars referred above (*as amended from time to time*), the following instructions are issued for the guidance of all Departments/Institutions:

- I. All Government Departments and Institutions including Hospitals, Jails, Autonomous Bodies, Government Undertakings and Government Aided Institutions, etc.; who require dietary consumable articles such as food grains, groceries etc. and non-dietary items for Departmental requirements shall make their purchases from the following Institutions provided that the rates/prices are certified as reasonable by the Assistant Registrar (Marketing) in the Office of the Registrar of Cooperative Societies. Tenders may not be invited by the Indenting Departments for supply of such dietary and non-dietary articles.
- (i) The Goa Co-operative Marketing & Supply Federation Ltd.
 - (ii) Shri. Navdurga V.K.S. Society, Pale, Bicholim.
 - (iii) Bardez Bazar Consumer Co-op. Societies, Mapusa.
 - (iv) Adarsha Krishi Kharedi Vikri Prakriya Sahakari Saunstha Maryadit, Balli.
 - (v) Goa Bagayatdar Sahakari Kharedi Vikri Saunstha Maryadit, Ponda.
