

## RESULTS OF ALL INDIA TRADE TEST OF CRAFTSMEN

The results of All India Trade Test of Craftsmen under Semester System(I,II,III &IV), Ex-failed and Regular Trainees(NCVT) held in the month of July,August,2017 (MIS) have been declared on the NCVT MIS PORTAL by the Ministry of Skill Development and Entrepreneurship, New Delhi. The results of All India Trade Test of craftsmen under semester system (2<sup>nd</sup>) ex-failed trainees admitted in the year 2013 and ex-failed trainees of 4<sup>th</sup> semester re-admitted in the year August 2015 (NCVT)Examination held in the month of July/August,2017(NON-MIS) have been declared by the Board of Examination of Directorate of Skill Development and Entrepreneurship, Goa.

The results of AITT (NCVT) under MIS are available on the NCVT MIS PORTAL<https://ncvtmis.gov.in/> and the results of AITT(NCVT) NON-MIS will be available in the respective ITIs ,as applicable.

All the Ex-failed trainees & Regular trainees who wish to re-appear/appear for the ensuing AITT of Craftsmen under semester system for (1<sup>st</sup>,2<sup>nd</sup>,3<sup>rd</sup> and 4<sup>th</sup> Semester) to be held in the month of January/February,2018 should approach the respective ITIs to fill their forms in all respects. The last date to receive such applications in the respective ITIs is December 5, 2017 and the same application along with the copy of Challan payment receipt, the statement of trainees appearing subject wise(Ex-failed) mentioned in Annexure-“A” should reach the examination cell, O/o DSDE, Panaji-Goa on December 8, 2017.The Last date to accept the examination fees by the respective ITIs from the regular trainees is December 5, 2017 and the Copy of Challan payment receipt along with Annexure-“B” ,statement of regular trainees likely to appear trade wise shall reach the examination cell on or before December 8, 2017.

Principal, Private ITIs shall collect the examination fees from ex-failed/regular trainees and submit the same alongwith the enclosing letter directly to the examination cell, O/o DSDE, Panaji-Goa for verification purpose and after duly certifying ,deposit the cash with the cashier, accounts section, O/o DSDE, Panaji-Goa on or before December 5, 2017. No application shall be entertained whatsoever after due date.

It is also informed that the Principals, Government/Private of respective ITI's should collect Rs.75/- (Rupees Seventy Five Only) towards OMR fees from the Regular and Ex-failed trainees who wish to appear/re-appear for AITT of Craftsmen under semester system (1,2,3&4) to be held in the month of January/February,2018 and submit the same alongwith the enclosing letter directly to the examination cell, O/o DSDE, Panaji-Goa for verification purpose and after duly certifying ,deposit the cash with the cashier, accounts section, O/o DSDE, Panaji-Goa on or before December 5, 2017.
