- (ix) The tenderer having more than two incomplete works in hand in this Division at the time of selling the tender document will not be eligible.
- (x) Attested documentary evidence from appropriate authority of having satisfactorily completed at least 3 similar works, each of value 40% of estimated cost or 2 similar works each of value 50 % of estimated cost or one work of 80% of estimated cost of the following nature in the last 7 yrs. ending last day of the month previous to the one in which the tenders are invited from Central/State Government organization, Central/Autonomous body, Central/State PSU.
- (xi) The tenderers shall be original manufacturer or an experienced electrical contractor who have satisfactorily who have satisfactorily executed & completed similar works in any Government Department/Semi Government Agency within a period of 7 years from the date of publication of tender.

All the documents and certificates pertaining to technical criteria shall be either in original or true copy of the same duly notarized or attested by Gazetted officer.

Such certificate shall be scanned and uploaded in the e-tendering web site.

All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebates is put forth or unconditional rebate is offered by bidder shall be summarily rejected.



### **INSTRUCTIONS TO CONTRACTORS**

1. The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
2. Information and Instructions for bidders posted on website shall form part of bid document.
3. The bid document consisting of plans, specifications, the schedule of quantity of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website [www.tenderwizard.com/GOA](http://www.tenderwizard.com/GOA).
4. Those bidders not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.
5. The intending bidder must have / obtain a valid Class-III digital signature to submit the bid.
6. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
7. Bidder must ensure to quote rate of each item.
8. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO). Also name of the bidder should be entered in respective cell
9. The tenderer shall be responsible for the correctness and genuine of the documents uploaded during tender submission. Any discrepancies in the matter will be liable for rejection and suitable action.
