ORDER

Sanction of the Government is hereby accorded to pay the following professional fees and other allowances to Senior Counsel, Shri. Atmaram N. S. Nadkarni, Ld. Additional Solicitor General of India for representing the State of Goa as Senior Advocate in matters before the Hon'ble Supreme Court of India, National Green Tribunal, Hon'ble High Courts and other Tribunals with effect from 01/12/2017, namely:-

- i. The Retainership of Rs.7.5 Lakhs shall be paid per month by the State Government to Shri Atmaram N.S. Nadkarni, Ld. Additional Solicitor General of India, who is appearing in various matters as Senior Advocate for the State, which would cover Conferences in various matters, including written opinions by Shri Atmaram N.S. Nadkarni, Senior Advocate.
- ii. In addition to the aforesaid, the fees of Shri Atmaram N.S. Nadkarni, Senior Advocate shall be increased to Rs. 3 Lakhs per appearance, except for Mahadayi matter which will continue to be governed by Order dated 07/04/2015.
- iii. The cost of upto four visits per month by Air Travel of Shri Atmaram N.S. Nadkarni, Senior Advocate for the State, to and from Delhi and Goa shall be borne by the Government.

The Senior Advocate, Shri. Atmaram N. S. Nadkarni, Ld. Additional Solicitor General of India shall submit the bills to Department of Law & Judiciary, Law (Estt.) Division, Secretariat, Porvorim-Goa for settlement.

The Senior Advocate, Shri. Atmaram N. S. Nadkarni, Ld. Additional Solicitor General of India shall submit his air fare bills to Department of Law & Judiciary, Law (Estt.) Division, Secretariat, Porvorim-Goa for reimbursement alongwith boarding pass.
