The Executive Engineer, Div.II (S&W), Aquem, Margao, invites online tenders on behalf of the Governor of Goa for **“Disposal of condemned vehicles & unserviceable materials”**. - i. Cost of tender documents – **Rs.500/-**.
- ii. EMD – 25% of bid amount per lot.
- iii. E-Tender Processing Fee – Rs. 1,500/-

All payments at (i), (ii), (iii) above are to be paid online through e-payment mode via NEFT/RTGS/OTC/debit card/credit card facility/net banking with preprinted challans available on e-tendering website and directly credit the amount to ITG account as generated by challans NEFT/RTGS/OTC.

Note: 1. Payment deposited through NEFT/RTGS/OTC should be made at least two bank working days in advance for successful reconciliation before any due date.

2. NEFT/RTGS/OTC receipt copy scan upload on the e-tender web site on or before tender submission date and time.


Interested contractor who wishes to participate in the tender has to make payments as mentioned above and scan the proof of payment and upload it to the e-tendering website within the period of last date and time for sale of tender documents and submit proof of payment mentioned at (i), (ii) and (iii) above with downloaded tender documents duly filled in before time and date specified for tender submission and as mentioned below for bid submission

The envelope marked ‘A’, ‘B’ & ‘C’ should be enclosed in a bigger envelope ‘D’ superscripted as **“Earnest Money, cost of tender documents, cost of tender processing fee and downloaded documents”** with the Tender no. 04 /17 for Disposal of condemned vehicles & unserviceable materials and due date of opening of the bid mentioned therein and shall be deposited at the Office of the Executive Engineer, Div.II (S&W), Aquem, Margao-Goa before 11.00 am. on 21/02/2018.

Failure to effect balance payment of 75% of the bid value within the stipulated time period prescribed or failure to take delivery of items by the successful bidder within three weeks of receiving the intimation from the Department or extended time period (if any), shall lead to forfeiture of the amount deposited by them.

The tender should be submitted through electronic mode only on or before 11.00 am. on 21/02/2018. and will be opened on the same day at 11.30 a.m. in the presence of tenderers or their authorized representatives if any present at the time of opening. Meanwhile, the tender opening event can be viewed online by logging in to the E-Tender site at the time of opening of the bid.
