

THE DECISION TAKEN BY THE CABINET

Item No.1

Labour Department

Proposal for discontinuation of the ongoing manual registration of Job Seekers in Employment Exchange and bringing in force the registration of Job Seekers and Employers on the NCS online portal and instructions/guidelines thereof for registration.

DECISION: The Council of Ministers resolved to approve to discontinue the ongoing manual registration of Job Seekers in Employment Exchange and bring in force registration of Job Seekers/Employers on the NCS online portal and instructions/guidelines thereof for registration on online NCS portal.

ITEM NO.2

Power Department

Appointment of 377 contractual Line Helpers in Electricity Department.

DECISION: The Council of Ministers resolved to grant ex-post facto approval for extension of contractual appointment of 377 contract Line Helpers for the period w.e.f. 15/11/2017 to 31/03/2018.

The Council of Ministers further resolved to grant ex-post facto approval for regularization of the extension in contractual appointment granted to contract Line Helpers for the period from 29/01/2015 to 28/01/2016, 29/01/2016 to 28/01/2017, 29/01/2017 to 28/04/2017 and fresh appointment from 15/05/2017 to 14/11/2017.

ITEM NO.3

Industries Department

Proposal for amendment of the "Goa State Incentives to Encourage Investments Schemes, 2017, "to be called as the "Umbrella Scheme".

DECISION: The Council of Ministers resolved to approve the following:

- (i) To approve the Goa State Incentives to Encourage Investments Schemes, 2017 to be called as the Umbrella Scheme enclosed as Annexure-I, in supersession of the existing scheme published in the Official Gazette No.3/10/2017-IND/268 dated 4-10-2017.
- (ii) To approve that Target Scheme- Capital Subsidy Scheme, 2017 under the Umbrella Scheme shall be notified with administrative approval and concurrence of Finance Department without further cabinet approval.

ITEM NO.4

Department of Civil Aviation

Guidelines for payment of additional three times compensation to the persons whose claims lands have been acquired and claims have settled for Mopa Airport project.

DECISION: The Council of Ministers resolved to approve the following guidelines for implementation of the scheme of payment of additional three times compensation to the persons whose lands have been acquired and claims have been settled by SLAO or by the Courts under Section 30 of the Land Acquisition Act, 1894

- (i) The scheme is applicable only to the persons whose lands have been acquired as appearing in the Land Acquisition Awards of SLAO or to the legal heirs in the event the person whose name is appearing in the Awards has expired as decided by SLAO or District Court as the case may be.
- (ii) The scheme is not applicable to the persons whose name is not appearing in the Land Acquisition Awards and who have purchased the land after the land acquisition process was set in motion by the SLAO through section 4 and section 6 notifications under the Land Acquisition Act, 1894.
- (iii) Additional three times compensation is an administrative decision of the Government and is not emanating from any provision under the Land Acquisition Act, 1894.
- (iv) Eligibility of additional three times compensation will be only after the initial compensation awarded by SLAO in the Land Acquisition Awards is received by the beneficiary.
- (v) Payment of additional three times compensation will be subject to availability of funds and budget provision.
- (vi) Beneficiary is not eligible for any interest in the event of any delay in making payment for any reason whatsoever.
- (vii) Government reserves the right to withhold and/or cancel the payment of additional three times compensation if any doubt arises with regard to the eligibility at any point of time.
- (viii) For the purpose implementation of this scheme, the Directorate of Civil Aviation will obtain the list of the compensation claims settled by SLAO or through District Court.
- (ix) In case of claims settled through the District Court, the SLAO has to furnish the copy of judgement along with the copy of receipt of payment received by the beneficiary through the Court.
- (x) In case the person to whom additional three times compensation sanctioned by the Government has expired then the procedure notified by the Government vide Order No.DOCA/Notes/42/247/719 dated 1-1-2018 for establishing legal heirs of the deceased shall be followed.

ITEM NO.5

Labour Department

Contractual appointment of Shri S.A. Deshprabhu as Advisor to the Office of the Commissioner, Labour and Employment, Panaji for the period of one year w.e.f. the date of joining the duties.

DECISION: The Council of Ministers resolved to approve the proposal for engagement of Shri S.A. Deshprabhu, Ex-Commissioner of Labour and Employment as an Advisor in Labour and Employment Department, on contract basis as a special case in view of the expertise of Shri S.A. Deshprabhu, beyond 65 years for one year only w.e.f. date of joining the duties on a consolidated remuneration to be fixed in terms of CCS (fixation of pay Re-employment Pensioners) Order, 1986.

ITEM NO.6

Department of Information Technology

Appointing M/s. Goa Electronics Limited (GEL) as on Implementation Agency for e-District Mission Mode Project on nomination basis.

DECISION: The Council of Ministers resolved to approve the proposal for Department of Information Technology for the following:

1. Ex-post facto approval for appointing M/s GEL as a Implementation Agency (IA) for e-District MMP on nomination basis through State Designated Agency M/s. Info Tech Corporation of Goa.
2. Approval towards making e-District Portal (www.goaonline.gov.in) as the Single Window Portal by integrating/linking various 'G2C' and 'G2B' services of all Government Departments.
3. Department of Information Technology will assess the reasonability of the cost proposed by M/s. GEL for the future services to be taken under e-District project.

ITEM NO.8

General Administration Department

Extending the benefits of the Sixth Central Pay Commission of Pay Band-I, Rs.5200-20200 with Grade Pay of Rs.1800/- to all Group "D" Staff appointed on Co-terminus basis in the Offices of Chief Minister/Ministers/Ld. Advocate General/Leader of Opposition and other dignitaries to whom the status of cabinet Ministers has been conferred by the Government to place them in Level-1 in Pay Matrix as per the recommendation of the Seventh Pay Commission.

DECISION: The Council of Ministers resolved to approve the following:

- (i) To place all the Peons (Group 'D') employees appointed in the Offices of Chief Minister/Ministers/Ld. Advocate General/Leader of Opposition and other dignitaries to whom the status of cabinet Ministers has been conferred by the Government prior to 01/01/2016, in the pay scale of PB-1, Rs.5200-20200 + Grade Pay of Rs.1800/- w.e.f 01/01/2016.
- (ii) To place all the Peons (Group "D") employees appointed after 01/01/2016 in the Offices of Chief Minister/Ministers/Ld. Advocate General/Leader of Opposition and other dignitaries to whom the status of cabinet Ministers has been conferred by the Government in the pay scale of PB-I, Rs.5200-20200 + Grade pay of Rs.1800/- w.e.f. the date of their initial appointment.
- (iii) Consequent upon placing in the pay scale of PB-1, Rs.5200-20200 + Grade pay of Rs.1800/-, to place them in the pay scale of Level-1 in Pay Matrix as per the recommendation of the Seventh Pay Commission and extending the monetary and other benefits of Seventh Pay Commission w.e.f. 01/01/2016 in respect of category (1) above and w.e.f. the date of initial appointment in respect of category (2) above.
- (iv) Any further appointments to the post of Peon (Group "D") in the Offices of Chief Minister/Ministers/Ld. Advocate General/Leader of Opposition and other dignitaries to whom the status of cabinet Ministers has been conferred by the Government, shall be made in Level-1 in Pay Matrix as per the recommendation of the Seventh Pay Commission.
