E-Tenders are invited to dispose off Unserviceable and Condemned Articles on "As is where is basis" so as to reach the Office of the **River Navigation Department, Betim** upto **5.00 PM on 24-09-2018**. eTenders will be opened in the office of the Captain of Ports, Panaji on the **26-09-2018 at 11.00 A.M**, during which period the tenderers or their authorized representatives may remain present.

**Mode of Payment towards Cost of the Auction Catalogue & Tender Processing Fee: To be paid online through e-payment mode via NEFT/RTGS/OTC/debit card/credit card facility/net banking with pre-printed challans available on e-tendering website and directly credit the amount to ITG account as generated by challans for NEFT/RTGS/OTC.**

The Condemned Articles shall be available for inspection from **21-08-2018 to 24/09/2018 up to 04:00 PM** (*During Office Hours & Working days by prior appointment*) at *Marine Workshop River Navigation Department, Betim-Goa.*

All the bidders should furnish EMD (Earnest Money Deposit) **To be paid online through e-payment mode via NEFT/RTGS/OTC/debit card/credit card facility/net banking with pre-printed challans available on e-tendering website and directly credit the amount to ITG account as generated by challans for NEFT/RTGS/OTC.**

- (a) Refund of Earnest Money:** The EMD of all of those bidders, whose bids are not accepted (*except that of the second highest bidders*), shall be returned after the date of auction. The EMD of the second highest bidder will be returned only after the finalization of sale with the highest bidder.
- (b) Mode of payment of Bid Value:** The EMD of the successful bidders will be adjusted against their respective final bid value(s). The balance **75%** of the bid value will be deposited by the bidders within **07 (seven)** days after getting intimation from the Auctioning Authority/Head of Department by way of Demand Draft in favour of the concerned department.
- (c) Forfeiture of Earnest Money:**
- i) Failure to effect balance payment:** In case the highest bidder fails to effect balance payment of 75% of the bid value within the stipulated time period prescribed, the second highest bidder can be considered if he fulfills the required criteria. In such cases the EMD deposited by the first highest bidder shall be forfeited in favour of Government.
  - ii) Failure to take delivery of items:** The successful bidder(s) shall take delivery of the items within **three weeks** of receiving the intimation from the Department. Failure to take delivery within the stipulated time period or extended time period (if any), the amount deposited by them shall stand forfeited to Government.
- d) GST** as applicable will be recovered from all the successful bidders at the prevailing rates on the amount quoted by the bidders on the bid articles at the time of final payment.
- e) The successful tenderers/bidders** upon acceptance of tender should get themselves registered under Goods and Service Tax Act, 2016 with the Office of Commissioner of Commercial Taxes, Government of Goa, Panaji-Goa and true copies of the certificates of such valid registrations should be submitted to the River Navigation Department, Betim-Goa, to enable this office for issue of Sale letter/Work Order.
- f) The tenderers/bidders** should have Digital Signature Certificate to participate in e-tendering mode.

g) The Department reserves the right to accept or reject any or all tenders without assigning any reason thereof.
