The quotation received without EMD in a separate envelope will be rejected. The government shall without prejudice to any other right or remedy, be at liberty to forfeit 50% of the EMD ,if any quotationer, whose quotation is accepted fails to commence the work specified in the work order within the prescribed time or abandons the work before its completion.
- 3) GST Registration Certificate has to be submitted.
