The average area of cultivation under the Sugarcane crop in the State has remained static over the year so also the average production. It is important to improve the productivity and area under sugarcane crop so that the crop is more remunerative for farmers and also there is adequate supply of cane to the only sugar factory in co-operative

sector in the State. This can be achieved by bringing new areas under the crop and by following Modified Sustainable Sugarcane Initiative (MSSI) techniques by the cultivators.

1. *Short title and commencement.*— (i) The scheme shall be called “Promotion of Modified Sustainable Sugarcane Initiative (MSSI)”.

(ii) The scheme shall come into force with immediate effect and shall remain in force till it is withdrawn.

(iii) The scheme shall cover all the talukas of the State of Goa.

2. *Objectives.*— (i) To raise the sugarcane nursery in polytrays using single bud.

(ii) To undertake transplanting of seedlings of 25-30 day age in the main field.

(iii) To ensure optimum plant spacing in the main field.

(iv) To ensure adequate moisture level by use of efficient irrigation system like drip irrigation.

(v) To encourage the cultivators for use of organic plant nutrients & plant protection measures.

(vi) To encourage inter cropping for effective utilization of land and for better remuneration.

3. *Selection of farmers.*— (i) The farmer claiming assistance under this scheme should be registered sugarcane grower with Sanjivani Sahakari Sakhar Kharkhana (SSSK) Ltd., Goa and should be desirous of bringing new area under the crop.

(ii) The land under cultivation should be in his/her own name or held on lease/contract or by power of attorney or by inheritance or as co-owner or under any other classification as shown on valid Krishi Card held by the farmer.

(iii) The farmers should invariably use single bud seedlings raised in polytray and follow the guidelines/techniques under MSSSI in consultation with SSSK, Goa/Directorate of Agriculture.

(iv) Before submission of claim at Zonal Agricultural Office, farmer shall obtain certificate from Sanjivani Sahakari Sakhar Kharkhana Ltd., Goa stating the authenticity about new area covered under the crop, techniques followed by the farmer under MSSSI with regards to use of single bud seedlings, maintenance of optimum spacing, efficient use of water etc.

4. *Pattern of assistance.*— The farmers will get assistance @ Rs. 10,000/- per ha. towards

the cost of land preparation and planting of single bud seedlings. The assistance will be 50% of the cost of expenditure on labour charges or Rs. 10,000/- per ha. whichever is less. The assistance will be provided to farmers on pro-rata-basis with minimum area of 2000 m² per farmer.

5. *General guidelines and procedure.*— (i) The farmers desirous of claiming assistance under the scheme shall apply to Zonal Agricultural Officer online in prescribed form alongwith scanned copy of certificate issued by Sanjivani Sahakari Sakhar Kharkhana Ltd., Goa, stating that he is registered grower with them and has brought 'X' M² new area under sugarcane crop during the year by following MSSSI guidelines.

(ii) Zonal Agricultural Officer shall verify the correctness of the claim/verification on site and determine the admissible amount of the assistance to the farmer as per the expenditure receipts/vouchers produced in support of the claim.

(iii) The claim thus received shall be uploaded for the scrutiny and sanction by the District Agriculture Officer, South/North-Goa.

(iv) The assistance under the scheme shall not operate if the amount of assistance is below Rs. 1000/-.

6. *Interpretation.*— If any question arises regarding interpretation of any clause, word, expression of the scheme, the decision shall be with the Government which shall be final and binding on all concerned.

7. *Redressal of grievances and disputes.*— Grievances if any, arising out of the implementation of this scheme, shall be heard and decided by the Hon'ble Minister for Agriculture and the decision of the Hon'ble Minister for Agriculture in this regard shall be final and binding on all concerned.

8. *Powers to Relax.*— The Government shall with prior consultation with the Finance

Department relax any or all the condition specified above to meet the objective of the scheme.

Government of Goa is pleased to frame the following scheme:—

“SCHEME FOR UPLIFTMENT OF UTSAVI RANGABHUMI OF GOA”

1. *Short title and commencement.*— (i) The scheme shall be called “SCHEME FOR UPLIFTMENT OF UTSAVI RANGABHUMI OF GOA”.

(ii) The scheme shall come into force from the date of its publication in the Official Gazette and shall remain in force up to March, 2022.

2. *Introduction.*— The “SCHEME FOR UPLIFTMENT OF UTSAVI RANGABHUMI OF GOA” has been designed with an objective to encourage the Festive theatre of Goa which is known as “GOMANTAKIYA UTSAVI RANGABHUMI”. This form of theatre has an illustrious tradition of presenting plays during festival in the villages. Most of the renowned actors of this motherland have the history of performing their first character role on Utsavi Rangabhumi, wherein more than 1000 plays were performed on the occasion of village deities’ festivals all over Goa.

However, due to emergence of prompting habits of text during the performance, lack of female stage artists’ participation, increase in the cost of stage setting, music, lights, and costume drapery and migration of village population to the cities, the performances of festive theatre have been declined and this tradition. Financial support and motivation from the Government could bring the festive theatre to its original glory. To develop, protect and preserve this traditional theatre the “SCHEME FOR UPLIFTMENT OF UTSAVI RANGABHUMI OF GOA” is designed.

3. *Objectives.*— The main objective of the scheme is as follows:—

(a) To revive and preserve the festive theatre of Goan villages.

(b) To encourage local village groups to restart the Houshi Rangabhumi theatre movement by providing necessary support for revival of sangeet natak. (Musical plays) performances and prose plays.

(c) To encourage local female artists and child artist for participation in these plays.

(d) To encourage amateur artists and to bring discipline in traditional festive theatre.

(e) To encourage new playwrights, directors, set designer and other stage technicians.

(f) To create bonding of unity and brotherhood through the medium of theatre in the villages.

4. *Scope of the scheme.*— (a) The scheme will attract the younger generation to the local theatre. The village artists could be trained in theatre by the experts through the Directorate of Art & Culture, Government of Goa.

(b) The female artists will be encouraged to participate in traditional “Utsavi Rangabhumi”.

(c) Sangeet Natak (Musical plays) will be revived which are presently at the verge of vanishing.

(d) The play writers will be encouraged to write new scripts i.e. prose as well as musical drama especially for traditional “Utsavi Rangabhumi”. The theatre groups will get opportunity to stage these plays.

(e) Theatre workshops of short duration will be conducted for the theatre groups of traditional utsavi rangabhumi to understand the basics of the acting and stage geography.

4. *Eligibility conditions.*— (1) This scheme will be applicable to the traditional village

festive theatre groups/amateur theatre groups. The group should have traditions of performing their plays during village deity festival through devasthan or village institutions.

(2) There has to be a tradition of performing the plays at least for 25 years.

(3) The theatre group has to give undertaking that they will present the play without prompting on the day of performance.

(4) The theatre group has to perform all the roles including that of the female in the drama from the same village. No professional artist will be allowed.

(5) Traditional theatre group from the same village has to perform the play as the tradition may be and the devasthan or village committee may certify the same.

(6) The theater groups shall provide all necessary details as required by the Department.

(7) There should be a Bank Account of the group in the Nationalized Bank in order to make payment.

(8) The village theatre groups could apply for financial assistance towards prose as well for sangeet natak. However, no group will get financial assistance for more than one play per year.

(9) The groups can apply every year under the scheme; however the selection will be made by the Government as per the recommendation of the selection committee and availability of funds.

5. *Quantum of Financial Assistance.*— The financial support will be as follows:—

(A) Financial Assistance for production of prose play will be maximum of Rs. 20,000/- (Rupees twenty thousand only) or 50% of the actual cost, whichever is less. However, the same could be decided by the selection committee from time to time depending upon the type of the play.

(B) Financial assistance for production of Sangeet play: Maximum of Rs. 30,000/- (Rupees thirty thousand only) or 50% of the actual cost, whichever is less. However, the selection committee may suggest the quantum from time to time.

(C) Department may identify few groups for providing directional support. In this case fees of the Directors & technical experts, including duration of short term production workshop will be decided by the Government from time to time. Undertaking in this regard from the concerned devasthan/traditional village institution/village committee shall require to be submitted.

(D) The selection committee may recommend an award of Rs. 3,000/- to the script writer for his new script if desires based on quality of the play.

(E) The financial assistance will be released as per availability of funds.

6. *Other terms and conditions.*— (1) If the traditional festive theatre group covered under this scheme desires to present their play in the state level competition, they will have to take prior permission of the Directorate of Art & Culture.

(2) The groups receiving financial assistance must exercise reasonable economy and observe all financial propriety as issued by the Government from time to time while incurring the expenditure.

(3) In case of misutilization of financial assistance, the amount so misutilised shall be recovered from the theatre group with 10% penal interest.

(4) The amount remaining unspent out of the financial assistance released shall be refunded back to the government treasury by way of challan immediately within 1 (one) month after the closure of the financial year.

(5) Any theatre group disobeying any rule under this scheme will be debarred from taking any benefit of the department.

7. *Selection procedure.*— (a) Number of groups to be selected under the scheme every year shall be decided by the Government from time to time.

(b) The theatre groups will be identified based on availability of funds.

(c) The selection of the traditional festive theatre group will be done every year by the committee appointed by the government.

(d) Recommendation of such selection of the theatre groups by the committee will be forwarded to the Government for the approval and only after the government approval groups will be released the financial assistance.

8. *Framing of guidelines.*— For better implementation of this scheme the Government shall frame the guidelines from time to time.

9. *Relaxation.*— The Government shall be empowered to relax any or all clauses

or conditions of the scheme in genuine cases.

10. *Interpretation.*— If any question arises regarding interpretation of any clause, word, expression of the scheme, the decision about the interpretation shall lie with the Government, which shall be final and binding on all concerned.

11. *Redressal of grievances and dispute.*— Grievances if any, arising out of the implementation of this scheme, the Government shall hear and decide such matters and the decision of the Government in this regard shall be final and binding on all concerned.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and in supersession of the Government Notification No. 1/27/2005-PER dated 3-6-2008, published in the Official Gazette, Series I No. 11 dated 12-6-2008, the Governor of Goa hereby makes the following rules to regulate the recruitment to the Goa General Service, Group 'A', Gazetted posts in the Goa College of Art under the Directorate of Technical Education, Government of Goa, namely:—

1. *Short title, application and commencement.*— (1) These rules may be called the Government of Goa, Goa College of Art under the Directorate of Technical Education, Group 'A', Gazetted posts, Recruitment Rules, 2017.

(2) They shall apply to the post specified in column (2) of the Schedule to these rules (hereinafter called as the "said Schedule").

(3) They shall come into force from the date of their publication in the Official Gazette.

2. *Number, classification and scale of pay.*— The number of posts, classification of the said posts and the scale of pay attached thereto shall be as specified in columns (3) to (5) of the said Schedule:

Provided that the Government may vary the number of posts specified in column (3) of the said Schedule from time to time subject to exigencies of work.

3. *Method of recruitment, age limit and other qualifications.*— The method of recruitment to the said posts, age limit,

qualifications and other matters connected therewith shall be as specified in columns (6) to (14) of the said Schedule.

4. *Disqualification.*— No person who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service:

Provided that the Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. *Power to relax.*— Where, the Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, and in consultation with the Goa Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. *Saving.*— Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for Scheduled Castes and other special categories of persons in accordance with the orders issued by the Government from time to time in that regard.

These rules are issued in consultation with the Goa Public Service Commission conveyed vide their letters No. COM/II/13/6(1)/2007/897, No. COM/II/13/6(2)/2007/898, No. COM/II/13/6(3)/2007/899, all dated 20-8-2014.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India the Governor of Goa hereby makes the following rules to regulate the recruitment to the Group 'B', Non-Ministerial, Non-Gazetted posts, in the Office of the Director General of Police, Government of Goa, namely:—

1. *Short title, application and commencement.*— (1) These rules may be called the Government of Goa, Office of the Director General of Police, Group 'B', Non-Ministerial Non-Gazetted posts, Recruitment Rules, 2017.

(2) They shall apply to the post specified in column (2) of the Schedule to these rules (hereinafter called as the "said Schedule").

(3) They shall come into force from the date of their publication in the Official Gazette.

2. *Number, classification and scale of pay.*— The number of posts, classification of the said posts and the scale of pay attached thereto shall be as specified in columns (3) to (5) of the said Schedule:

Provided that the Government may vary the number of posts specified in column (3) of the said Schedule from time to time subject to exigencies of work.

3. *Method of recruitment, age limit and other qualifications.*— The method of recruitment to the said posts, age limit, qualifications and other matters connected therewith shall be as specified in columns (6) to (14) of the said Schedule.

4. *Disqualification.*— No person who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service:

Provided that the Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. *Power to relax.*— Where, the Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, and in consultation with the Goa Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. *Saving.*— Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for Scheduled Castes and other special categories of persons in accordance with the orders issued by the Government from time to time in that regard.

These rules are issued in consultation with the Goa Public Service Commission vide their letters No. COM/II/13/37(3)/2016/310 dated 6-6-2017 and COM/II/13/37(4)/2016/308 dated 6-6-2017.

Sanction of the Government is hereby conveyed to the Pattern of Assistance to incur annual expenditure of Rs. 5.00 crores to Goa Waste Management Corporation (GWMC), Saligao-Goa towards implementation of the mandate of the Monitoring-cum-Working Committee.

1. Grant-in-aid will be sanctioned for the initial non-recurring cost of establishment of the Goa Waste Management Corporation for supporting, consolidation and assisting in the activities being carried out and implemented by the Monitoring-cum-Working Committee vide Order No. 3-188-2011/STE-DIR/2236 dated 09-03-2011 of the various Government Departments, Local Panchayats, NGOs etc., including generating awareness providing technical support, equipment, human resource, components for projects etc. working in the field of Solid Waste Management. The release of Grant-in-aid will be reviewed every year taking into consideration the quantum of revenue, if any, generated by the GWMC and their expenditure. Any other expenditure proposed to be incurred, which is not covered above, shall be done with prior approval of DSTE.

2. The GIA of Rs. 5.00 crores will be released under the Budget Head: 3435 — Ecology and Environment; 60 — Others; 800 — Other Expenditure; 06 — Management of Solid Waste and Other Wastes in Goa (Plan); 31 — Grant-in-aid.

3. The GWMC, Saligao shall monitor enforcement programmes in terms of the Goa Non Biodegradable Garbage (Control) Act, 1996 & Rules, 1997 and the Plastic Waste (Management and Handling) Rules, 2011. The GWMC shall plan and implement programmes for creating awareness at all levels on

segregation and solid waste management, awareness programmes for schools/ /institutions and generating learning material in this regard. The GWMC will assist Village Panchayats in the safe disposal of solid waste. They will also look into the aspects regarding the provisions of Plastic Waste (Management and Handling) Rules, 2011 and suggest various measures for implementation and improvement in the legislation/rules in respect of the same.

4. Department of Science, Technology and Environment (DSTE) shall provide appropriate financial assistance in the form of Grant-in-aid to GWMC, to undertake various activities including costs towards incidental expenses like travel, conduct of meetings, conduct of awareness programmes, generation and preparation of literature and learning material, providing technical support/equipment, human resource components for the projects to be undertaken etc.

5. The GWMC shall prepare their budget for every financial year. Accordingly, grants shall be released on quarterly basis based on the expenditure during the previous year.

6. The entire amount of the Grant-in-aid should be utilized within a period of one year from the date of sanction and only for the purpose for which it is sanctioned. Any portion of the grant which is not ultimately required for the purpose for which it is sanctioned will be refunded in cash to the Government Treasury. After utilizing/ /refunding the above sanctioned amount a utilization certificate should be furnished to the sanctioning authority.

7. The equipment purchased with the Grant-in-aid shall vest in the Government. The GWMC shall maintain a register in form G.F.R. 19 of the permanent and semi-permanent assets acquired wholly or partly out of the Government grants. The register shall be maintained separately in respect of the grants sanctioned and an extract from the register shall be furnished to the Government annually

with the audited statement of accounts after the close of the financial year. Such assets shall not be disposed off, encumbered or utilized for the purpose other than those for which the grant was given, without prior approval of the Government. In the event of GWMC ceases to exist, at any time, such assets/properties shall be reverted to the Government.

8. The accounts of the GWMC should be audited by the Government Auditor immediately after the end of the financial year. The accounts of the grant shall be maintained separately and properly from its normal activities and submitted as and when required. They shall be open to a test check of the Comptroller and Auditor General in India, at his discretion.

9. The audited statement of accounts showing the expenditure incurred by the GWMC from the grants should be furnished to the Government as soon as possible after the close of the financial year together with a certificate from the Auditor to the effect that the grant was utilized for the purpose for which it was sanctioned.

10. A performance-cum-achievement report specifying in details of the achievements made by the GWMC with the Government grants should be furnished to the Government as soon as possible after the close of the financial year.

11. The GWMC shall observe all the rules and regulations framed by the Central Government under Section 3 of the Environment (Protection) Act, 1986.

12. The Grant-in-aid shall be drawn in TR 42 duly signed by the Competent Authority and shall maintain necessary register and ensure compliance of all conditions by the grantee.
