**NOTICE INVITING QUOTATION**

Sealed Item Rate quotations are invited from the eligible bidders for the work of **"Demolition of Old Morgue building of Forensic Medicine and Toxicology, Bambolim and Old Kitchen Block of T.B Hospital, St.Inez, Panaji"**. The sealed quotations shall be received **upto 15:00 hours on 27<sup>th</sup> September 2019** and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is **Rs.5,77,816.00**

The Schedule of Quantities including the description of the item is furnished in **ANNEXURE-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **ANNEXURE-I** while submitting the quotation. The Contractor shall include all the taxes as applicable in the rates quoted for various items specified in the bill of quantities except for Goods & Service Tax (GST) which will be paid as per the prevailing applicable rate during execution of work. Bidders will ensure that full benefit of input tax likely to be availed by them is duly considered while quoting rate. All the pages of **ANNEXURE-I, ANNEXURE-II, ANNEXURE-III** shall be duly stamped and signed. The general terms and conditions and list of approved brands are furnished in **ANNEXURE-III**.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs.11,600.00** (Rupees Eleven Thousand Six Hundred only) in the form of Demand Draft from the Nationalised / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

Bidders may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be **26<sup>th</sup> September 2019 upto 17:30 hours**.

In case of delay, the successful bidder shall be liable to pay to the Employer an amount of **Rs.1540.00** (Rupees One Thousand Five Hundred Forty only) per day as Compensation for delay for default for every day. However, such total amount as Compensation for Delay shall not exceed 10% of the original quotation price.

The work shall be completed within **45 days** from the tenth day of issue of Work Order

**ANNEXURE III**

**GENERAL TERMS AND CONDITIONS**

**1. General**

The requirements under this Section shall be deemed to be general particulars & requirements related to the work and shall be applicable to all Sections, whether specifically mentioned or not. Work under this Contract shall be executed as given in the Specifications and required at Site whether specifically shown or not.

The Item description given in Bill of quantities (BOQ) wherever specification numbers are mentioned, refer technical specification of Public works department (Electrical and Civil) Government of Goa. The Contractor shall take Joint Measurement of Records with the official of GSIDC prior to demolishing the building. The JMR has to be recorded and signed by the Contractor personnel and official of GSIDC prior to demolition.

**2. Rates**

The rates quoted shall be inclusive of all works whether specified or otherwise and which is required for satisfactory execution of the Item. The Contractor shall take all the necessary precaution while demolishing the building to prevent the other buildings in the vicinity from getting damaged. Failure to do so, shall attract necessary action as deemed fit by GSIDC.

The Contractor shall include all the taxes as applicable in the rates quoted for various items specified in the bill of quantities except for Goods & Service Tax (GST) which will be paid as per the prevailing applicable rate during execution of work. Bidders will ensure that full benefit of input tax likely to be availed by them is duly considered while quoting.

**3. Tools**

The Contractor shall arrange for necessary tools and equipment required for demolishing. It is the responsibility of the contractor to stack the unserviceable material properly on site prior to disposal. However, the Contractor shall dispose all the unserviceable material, lime, moorum, building debris/rubbish by mechanical/manual means by transport including loading, unloading and disposal of all material to the location identified by Client/Government/Public works Department.
