

DECISIONS TAKEN IN THE CABINET MEETING HELD TODAY

The following decisions were taken by the Council of Ministers in the Cabinet meeting held on October 23, 2019 at Ministerial Block, Porvorim.

The Council of Ministers resolved to approve the proposal for re-transferring a portion of land admeasuring an area of 2530 sq. mts. of plot No.'C', under Survey No. 129, Sub Division No. 1-A in Penha De Franca Village Panchayat, Porvorim, Bardez Taluka, from Water Resources Department, Government of Goa to the General Administration Department, Government of Goa.

The Council of Ministers further resolves to approve the proposal for according ex-post facto approval for the construction of the building "Sahakar Bhavan" at Curti, Ponda-Goa.

Council of Ministers also resolved to grant ex-post facto approval for additional 12% compensation amount of Rs. 18,79,005/- to be paid to the concerned land owners for purchase of land of Village Assolda, Xic-Xelvona and Curchorem of Quepem Taluka and villages Sanvordem and Calem of Sanguem Taluka for Kulem-Madgaon Doubling of South Western Railway Project, as per the policy on procurement of land under Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

The Council of Ministers further resolved to approve for discontinuation of enrolment of Goa Government employees and their dependants under the Deen Dayal Swastha Seva Yojana (DDSSY) Scheme, since they are governed under the existing Medical Attendance Rules.

Council of Ministers also resolved to approve the amendment to the Business of the Government of Goa (Allocation) Rules, 1987, as per the draft Notification **annexed hereto** duly vetted by Law Department.

The Council of Ministers resolved (1) to delete the Clause "Successful completion of pre-employment training under the Pre-Employment Training Scheme conducted by the Government of Goa" (said clause) from the Recruitment Rules of the posts, namely; Junior Stenographer, Lower Division Clerk, Heavy Vehicle Driver and Light Vehicle Driver. (2) To grant ex-post facto approval for deletion of the said clause from the Recruitment Rules of Government Primary School Teacher.

Council of Ministers resolved to grant ex-post facto approval for extension in service to Shri Devadasan A., C.H. Rajgopalan and Shri Sunil Wadekar, Executive Engineers, Electricity Department beyond the date of superannuation for a period of four months **w.e.f. 01/06/2019 to 30/09/2019.**

The Council of Ministers resolved to

1) Discontinue the Special Mechanism viz. Inter-Departmental Committee of Officers (IDCO) and High Level Empowered Committee (HLEC) constituted vide order No.1/1/2017-Addl.Secy(PER) dated 22/11/2017.

2) Restore the process of creation/abolition of posts through Administrative Reforms Department, Finance Department and Department of Personnel

3) The proposal for revival of the lapsed posts of all the Departments whose assessment of strength is complete are to be referred to Department of Personnel and thereafter to Finance Department for concurrence.

4) The proposal for new contract appointments are to be dealt by the Department of Personnel and thereafter by Finance Department for concurrence.

5) The proposals for outsourcing of activities such as house- keeping, Security etc. are to be dealt by the Department of Personnel and thereafter by Finance Department for concurrence.

6) The proposals for purchase or outsourcing of vehicles are to be dealt by the Finance Department.

7) All the proposals pertaining to the amendment of orders or review of any decision of the High Level Empowered Committee (HLEC) are to be dealt by the Administrative Reforms Department in consultation with the Department of Personnel and Finance Department.

The Council of Ministers resolved to accord approval for the proposal submitted by Entertainment Society of Goa and approved by Expenditure Finance Committee during its meeting held on 14.10.2019 to invite the e-tender under "Two bid system i.e. Technical and Financial bid" for the work of **"Selection of Operator for Renovation/Refurbishment and Operation of Multiplex at ESG Complex, Campal, Panaji - Goa"**. Minister concerned may relax any of the eligibility criteria, if required in future during the tendering process.

The Council of Ministers resolve to: Regularize the supply order placed to the Goa State Co-op & Marketing & Supply Federation, Panaji and grant ex-facto expenditure sanction for Rs.44,40,576/- as per the bill received by the Goa State Co-op marketing supply federation Ltd. Panaji-Goa.
