

NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible contractors/authorized dealers & service providers for the work of **“Construction of IInd Phase of Dental College at Bambolim, Goa-Dismantling of 11KV Overhead line & laying of Underground Cable”** The sealed quotation shall be received upto 15:00 hours on 26th February, 2020 and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is **Rs.9,67,240.80.**

The Schedule of Quantities including the description of the item is furnished in **Annexure-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **Annexure-I** while submitting the quotation. Rates shall be inclusive of all taxes except GST. GST will be paid extra as applicable at the time of billing. All the pages of Annexure –I, II & III shall be duly stamped and signed. The general terms and conditions are furnished in **Annexure-III.**

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs.19,400.00** (Rupees Nineteen Thousand Four Hundred only) in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **Annexure-II**, duly typed/handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

Bidders having a valid electrical license (11KV or above) may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be 25th February, 2020 upto 17.45 hours.

In case of delay, the successful bidder shall be liable to pay to the Employer an amount of **Rs.2,580.00** (Rupees Two Thousand Five Hundred Eighty only) per day as Liquidated Damages for default for every day. However, such total amount as Liquidated Damages shall not exceed 10% of the original quotation price.

The work period shall be of 2 months and will commence from 10th day after the date of issue of Work Order / Letter of Acceptance.

GSIDC reserves the right to accept or reject any or all the quotations in part or full without assigning any reason whatsoever.
