MINIMUM ELIGIBILITY CRITERIA FOR BIDDERS

The bidder should have valid registration for e-Tendering with GSIDC. The bidder should have in the last

7 years **ending 31st January 2020** successfully completed as a prime contractor atleast one similar work of value not less than **Rs. 10.73 Crore** or two similar works each of value not less than **Rs.8.04 Crore** or three similar works each of value not less than **Rs.5.36 Crore**. **The term similar work means ‘construction of building’.**

The attested copies of original work orders (in case of non-Government works only) and completion certificates indicating the specified required works indicated as above issued by the clients should be scanned (PDF format) and submitted online along with the bid. **The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of submission of e-Tenders.**

FINANCIAL CRITERIA:

- a. The bidder should have an average annual turnover of atleast **Rs. 4.02 Crore** in the last 3 consecutive financial years. The attested copies of original Audited Profit & Loss account and original Balance Sheet statement for the last three consecutive financial years should be scanned (PDF format) and submitted online along with the bid.

MINIMUM ELIGIBILITY CRITERIA FOR BIDDERS

TECHNICAL CRITERIA:

The bidder should have valid registration for e-Tendering with GSIDC. The bidder should have in the last 7 years *ending 31st January 2020* successfully completed as a prime contractor at least one similar work of value not less than **Rs. 2.39 crore** or two similar works each of value not less than **Rs. 1.79 crore** or three similar works each of value not less than **Rs. 1.19 crore**. The term “similar work” means **Hospital Furniture, Kitchen Equipment and Interior works/Interior works.**

The attested copies of original work orders (in case of non-Government works only) and completion certificates indicating the specified required works indicated as above issued by the clients should be scanned (PDF format) and submitted online along with the bid. *The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of submission of e-Tenders.*

FINANCIAL CRITERIA:

- a. The bidder should have an average annual turnover of at least **Rs. 89.76 lakhs** in the last 3 consecutive financial years. The attested copies of original Audited Profit & Loss account and original Balance Sheet statement for the last three consecutive financial years should be scanned (PDF format) and submitted online along with the bid.

The bidder should have in the last 7 years **ending 31st January 2020** successfully completed as a prime contractor atleast one similar work of value not less than **Rs.214.00 lakhs** or two similar works each of value not less than **Rs.161.00 lakhs** or three similar works each of value not less than **Rs.107.00 lakhs**. **The term similar work means works involving interiors, modular furnitures and kitchenwares.**

The attested copies of original work orders (in case of non-Government works only) and completion certificates indicating the specified required works indicated as above issued by the clients should be scanned (PDF format) and submitted online along with the bid. ***The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of submission of e-Tenders.***

FINANCIAL CRITERIA:

- a. The bidder should have an average annual turnover of atleast **Rs.80.15 lakhs** in the last 3 consecutive financial years.
