**ADDENDUM**

**Under Section 144 of the Code of Criminal Procedure of 1973 and the  
Goa Epidemic Disease, COVID-19 Regulations, 2020.**

In continuation of order read above and in terms of the powers vested in me under section 12 of the Goa Epidemic Disease, COVID-19 Regulations, 2020 the following essential services shall be exempted from closure in North Goa District with immediate effect to **00:00 hrs of 26/03/2020 (i.e. intervening midnight of 25<sup>th</sup> March 2020 and 26<sup>th</sup> March 2020)**

1. Offices charged with Law and Order and magisterial duties
2. Police/Defence Establishments/Central Police and Paramilitary Organizations
3. Health
4. Fire
5. Prisons
6. Electricity
7. Water supply, bottled water and sewerage
8. Municipal services
9. Solid Waste Management
10. Community & Public Toilets
11. Animal Husbandry, Animal/Cattle feed and Veterinary Services
12. Directorate of Accounts only for salary/wages/contingent/health & essential services related expenditure
13. Print and Electronic Media
14. Scheduled Banks and ATMs
15. Telecom, Internet and postal services
16. Shops of food, groceries, milk, bread, fruit, vegetable, meat, fish etc including department stores and super markets will be allowed to be open between 6 am and 11 am every day.

18. Chemists including pharmaceuticals manufacturing, distribution and wholesalers
19. Petrol pumps, LPG gas, oil agencies and their godowns and transportation activities
20. Production and Manufacturing units which require continuous process; after obtaining required permission from the District Magistrate
21. Manufacturing units engaged in production of essential commodities
22. All other services declared as Essential services from time to time by Government of Goa
23. Private establishments that support the above services or are linked to the efforts for containment of COVID-19
