ORDER

Issue of Travel Permit

Vide Order No. 8/8/2020-MAG/L&O/(VOL-I)/968 dated 23/03/2020 Prohibitory Order under Section 144 Cr. P.C. has been issued restricting assembly of 4 or more persons. Further, as per Order No. 8/8/2020-MAG/L&O/(VOL-I)/990 dated 24/03/2020 movement of vehicles has been restricted in North Goa District till 14th April, 2020.

In view of this, the following Standard Operating Procedure will be followed for issue of Travel Permit:

1. The vehicles engaged in providing / carrying essential goods and services arriving at the district borders will be provided Travel Permit by Mamlatdars/Jt. Mamlatdars posted at the district borders.
2. Establishments/shops/NGOs/Volunteers engaged in home delivery of essential commodities/supplies shall carry valid Travel Permits without which they shall not be permitted to move. Also, any such movement will only be permitted in their designated area as mentioned on the Travel Permit issued by the respective Deputy Collector.
3. The Head of Department of the concerned department shall issue Travel Permit for the respective departmental staff who do not possess valid Government Identity Cards.
4. The Director of Information & Publicity shall issue passes for Media personnel.

5. The authorised officer of Banks shall issue Travel Permit to outsourced staff handling activities for the Banks.
6. Persons travelling for medical emergency in private vehicles shall be permitted.
7. Staff of private hospitals/pharmacies shall carry valid photo ID. Cards issued by authorised person of respective hospitals/pharmacies.
8. Security Agencies (Government/Private) personnel in uniform and carrying valid ID card shall be permitted.

Any person or Organization desirous of obtaining the Travel Permit will apply to the District Magistrate, North Goa with details of the vehicle number, name of the person, father's name, purpose for which required to travel and "from" and "to" places. On receipt of the application, after examining the requirement of travel, the District Magistrate shall issue the Travel Permit with validity period. Travel Permit will be displayed on the vehicle. Only such vehicles with valid Travel Permit will be permitted to ply.

The format for the Travel Permit is enclosed.

ORDER

Whereas there is a prevailing situation in the Country due to the health emergency posed by COVID-19 an infectious disease caused by Corona Virus;

AND WHEREAS, the Ministry of Home Affairs, vide order No.40-3/2020-D dated 24/3/2020 has issued the guidelines on the measures to be taken by Government for the containment of COVID-19 in the Country;

AND WHEREAS, vide point No.14 & 15 of the said guidelines provision is made for movement of essential goods for which passes will be issued by respective Incident Commanders;

NOW THEREFORE, in exercise of powers vested in me under Section 30(5), 34(b), 34 (c) of the Disaster Management Act, 2005, I hereby empower the Deputy Collectors/SDMs of North Goa District to issue authorization to establishments/shops/NGOs/volunteers to carry out home delivery of essential commodities and Travel Permit to vehicles engaged for this purpose within their respective jurisdiction.

Any person contravening this order shall be punishable under Sec.51 to 60 of Disaster Management Act., 2005 and Sec. 188 of the Indian Penal Code.
