2. Last date for online submission of tender document is on 15/04/2020 upto 15.00 Hrs.
3. The Tender Technical bid will be opened online on 22/04/2020 at 10:30 hrs. in the office of Director of Animal Husbandry & Veterinary Services, Panaji-Goa and thereafter the Financial Bid will be opened only of those tenderers who fulfill the terms and conditions in the Technical Bid.

The dates mentioned above shall be treated as the next working day if any of the dates falls on holidays.

Eligible supplier may request for the tender documents through the website <https://goaenivida.goa.in/> on the following conditions:-

1. Document evidence to substantiate that bidder is authorized by the Producers/storage company.
2. Valid license from PESO for storage and filling of LN2.
3. Quantity will not be fixed every time when vehicle will come at Vendor Site with the available LN2 Cryo Vessels of this Directorate including the cryo vessels mounted on Tata Truck which should be filled Approximately 4 to 5 Times a Month . Aprox. Vol. may vary from 2200 ltrs. to 3000 ltrs per Month.

4. The firms must have Minimum 20,000 Liters of storage capacity or will have to enclose a copy of Authorization Certificate from the firm who holds this capacity.
5. Attested copy of PAN card.
6. Attested copy of GST Certificate.
7. The Authorized dealer/Bidders shall need to submit a notarized affidavit on Rs.100.00 non-judicial stamp paper indicating that they have not been black listed by any of its customers across the country.
8. Bidder Vendor should have previous experience of supplying to department AHVS/ Dairy Sector/ Cooperatives or to any other Government Department like Health or other Institutions.
9. Name and address of Storage location of vendor site should be within the State of Goa boundary.
10. Average Turnover of Minimum 10 Lakhs for last 3 financial years certified by Chartered Accountant should be attached for ascertainment.
11. Copy of latest (Assessment year 2019-2020) Income Tax Returns.
12. EMD of Rs. 21,000/- (Rupees Twenty One Thousand only)
13. Work experience of prospective bidder should be as below
 - (c) Three similar Supplies costing not less than the amount equal / greater than Rs. 6 lakhs OR
 - (d) Two similar Supplies works costing not less than the amount equal / greater than Rs. 8 lakhs OR
 - (C) One similar Supplies works costing not less than the amount equal / greater than Rs. 10 lakhs
14. Mode of payment towards tender document fee (TDF), e-Tender Processing Fee (TPF) & Earnest Money Deposit (EMD) to be paid online through e-Payment mode via: National Electronic Fund Transfer (NEFT) / Real- Time Gross Settlement (RTGS) / Over –the-counter (OTC) Debit Card/ Credit Card facility / Net Banking with pre-printed challan available on e-tendering website and directly credit the amount to ITG account as generated by challans for NEFT/RTGS/OTC.
Note: Any payment mode through NEFT/RTGS/OTC will take 24 hours for its reconciliation. Hence the payment through NEFT/RTGS/OTC should be made at least TWO BANK WORKING DAYS in advance before any due date. The bidder won't be able to proceed with bid submission until the money has been received in the ITG's account.
