

NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible bidders for the work of “**Major Maintenance Work of Goa Medical College & Hospital at Bambolim, Goa SH: Maintenance Contract for Ductable Air Conditioners at Ward 117, Ward 131 and Ward 126 at Goa Medical College and Hospital, Bambolim for one year- 2nd Call.**”. The sealed quotations shall be received **upto 15:00 hours on 2nd June 2020** and the same will be opened at **15.30 hours** on the same day. The estimated cost for the work is **Rs. 1,30,500.00**.

The Schedule of Quantities including the description of the item is furnished in **ANNEXURE-I & ANNEXURE-III** enclosed herewith. The bidder shall include all the taxes as applicable in the rates quoted for various items specified in the bill of quantities except for Goods & Service Tax (GST) which will be paid as per the prevailing applicable rate during execution of work. Bidders will ensure that full benefit of input tax likely to be availed by them is duly considered while quoting rate. All the pages of **ANNEXURE-I & ANNEXURE-III** shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs. 2,610.00** (Rupees Two Thousand Six Hundred Ten only) in the form of Demand Draft from the Nationalised / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

Bidders in the field of similar work may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be **1st June 2020 upto 17.30 hours**.

The security deposit shall be collected by deduction from the bill at the rate of 5% and the Earnest Money deposited will be treated as part of Security Deposit. The Security Deposit shall be released on completion of Maintenance Period. In the event of failure of the Contractor to properly remedy the defects, the security deposit shall be released with appropriate deduction.

The work shall be completed within 12 Months from the date of issue of Work Order / Letter of Acceptance.

GSIDC reserves the right to accept or reject any or all the quotations in part or full without assigning any reason whatsoever.
