SHORT NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible bidders for the work of **“Renovation/Maintenance of Hospitals, CHCs, PHCs, RMDs under Directorate of Health Services in North Goa – S.H. Maintenance of fire fighting systems of hospitals under DHS: Community Health Centre, Sankhali – Goa”**

The sealed quotations shall be received **upto 15:00 hours on 19th May 2020** and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is **Rs. 11,84,730.00**.

The Schedule of Quotations including the description of the item is furnished in **ANNEXURE-I & ANNEXURE-III** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **ANNEXURE-I** while submitting the quotation. The Contractor shall include all the taxes as applicable in the rates quoted for various items specified in the bill of quantities except for Goods & Service Tax (GST) which will be paid as per the prevailing applicable rate during execution of work. Bidders will ensure that full benefit of input tax likely to be availed by them is duly considered while quoting rate. All the pages of **ANNEXURE-I & ANNEXURE-III** shall be duly stamped and signed. The general terms and conditions and list of approved brands are furnished in **ANNEXURE-III**.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs.23,700.00** (Rupees Twenty Three Thousand Seven Hundred only) in the form of Demand Draft from the Nationalised / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

The bid shall be submitted in two sealed envelopes marked as follows:

Envelope 1 – E.M.D

A bid not accompanied by Earnest Money Deposit will not be considered.

Envelope 2 – Financial Bid

Original copies of Annexure - I duly filled and duly signed and stamped.

The above mentioned envelopes shall be again put together in one common outer cover/ envelope and sealed, superscribed in capital letters along with the title of the project.

All three envelopes shall be marked on the left hand top corner thus:

“Renovation/Maintenance of Hospitals, CHCs, PHCs, RMDs under Directorate of Health Services in North Goa – S.H. Maintenance of fire fighting systems of hospitals under DHS: Community Health Centre, Sankhali – Goa”

Have full name and address of the bidder written or typed on these envelopes. Indicate the contents. If all envelopes are not sealed, superscribed or submitted in any other than mentioned format, GSIDC will assume no responsibility for the misplacement or premature opening of the bid submitted and bid may be rejected by GSIDC.

Bidders in the field of similar work may peruse the Schedule of Quotations and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be **19th May 2020 upto 15.30 hours**.

In case of delay, the successful bidder shall be liable to pay to the Employer an amount of **Rs.1600.00** (Rupees One Thousand Six Hundred only) per day as Liquidated Damages for default for every day. However, such total amount as Liquidated Damages shall not exceed 10% of the original quotation price.


The Security Deposit shall be collected by deductions from the running/ final bill at the rate of 5% and the Earnest Money deposited will be treated as part of the Security Deposit. A sum of 5% of the gross amount of the bill shall be deducted from the running/ final bill of the Contractor till the sum along with the sum already deposited as Earnest Money will amount to Security Deposit of 5% of Contract Price of the work.

The Security Deposit shall be released on successful completion of 1 year from the date of completion of the work. The security deposit shall be released in full only if all the required maintenance and / or repairs have been carried out by the Contractor in timely manner, to the complete satisfaction of the Engineer.

In the event of failure of the Contractor to properly remedy the defects, the security deposit shall be released with appropriate deduction.

The work shall be completed within **100 Days** from the tenth day of issue of Work Order/Letter of Acceptance.

GSIDC reserves the right to accept or reject any or all the quotations in part or full without assigning any reason whatsoever.
