SHORT NOTICE INVITING QUOTATION

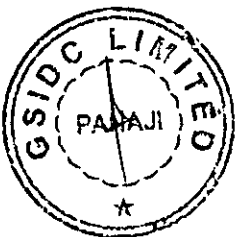
Sealed Item Rate quotations are invited from the eligible bidders for the work of **"Upgradation of Cansaulim Primary Health Centre (PHC) in Cortalim Constituency – Providing & fixing bronze bust of late Shri Matanhy Saldanha"**. The sealed quotations shall be received upto 15:00 hours on **11th May 2020** and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is Rs.2,00,000.00.

The Schedule of Quantities including the description of the item is furnished in **Annexure-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **Annexure-I**, while submitting the quotation. The Contractor shall include all the taxes as applicable in the rates quoted for various items specified in the bill of quantities except for Goods & Service Tax (GST) which will be paid as per the prevailing applicable rate during execution of work. Bidders will ensure that full benefit of input tax likely to be availed by them is duly considered while quoting rate. All the pages of **Annexure-I** shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to Rs.4,000.00/- (Rupees Four thousand only) in the form of Demand Draft from the Nationalised / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa, along with a covering letter, as per the format enclosed at **Annexure-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected. The EMD of the successful bidder shall be appropriated as security deposit and shall be refunded after total completion of the work.

Bidders in the field of fabrication of bronze bust works may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be **8th May 2020 upto 17:30 hours**.

The work period shall be of 2 months and will commence from the day of issue of Work Order / Letter of Acceptance.



If the Contractor desires to avail any advance payment, then the same shall be paid against a Bank Guarantee of an equivalent amount valid for atleast a period of completion.


The Contractor should take approval of Clay model from GSIDC before casting of the bronze bust.

Security Deposit shall be collected by deductions from the running bills at the rate of 5% and the Earnest Money deposited will be treated as part of the Security Deposit. Earnest Money shall be adjusted first in the security deposit and further recovery of security deposit shall commence only when the upto date amount of security deposit starts exceeding the earnest money. A sum of 5% of the gross amount of the bill shall be deducted from each running bill of the Contractor till the sum along with the sum already deposited as Earnest Money will amount to Security Deposit of 5% of Contract Price of the work. Security deposit shall be released after successful completion of the work.

The above mentioned amounts shall be released in full only if all the required work has been carried out by the Contractor in a timely manner, to the complete satisfaction of the Engineer/Employer. In the event of the failure of the contractor to properly remedy the defects, the security deposit amount shall be released with appropriate deductions.

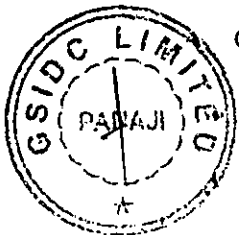

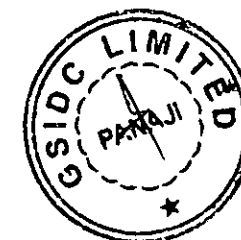
