

**SHORT NOTICE INVITING QUOTATION**

Sealed Item Rate quotations are invited from the eligible bidders for the work of **“Interior Work for setting up of Software Technology Park in Goa at Udyog Bhavan, Panaji, Goa - Replacement of faulty HT/ LT cables and repair of existing Megawin make 11 KV Load Break Switch”**. The sealed quotations shall be received **upto 15:00 hours on 3<sup>rd</sup> July 2020** and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is **Rs.2,55,229.00**

The Schedule of Quantities including the description of the item is furnished in **ANNEXURE-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **ANNEXURE-I** while submitting the quotation. Rates shall be exclusive of GST. All the pages of **ANNEXURE-I** shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs.5,105.00** (Rupees Five Thousand One Hundred and Five only) in the form of Demand Draft from the Nationalised / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD and valid 11kV Electrical License in the specified format shall be summarily rejected.

Any electrical contractor having executed electrical works and having valid electrical license up to 11kV may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be **3<sup>rd</sup> July 2020 upto 13.00 hours**.

The security deposit shall be collected by deduction from the bill at the rate of 5% and the Earnest Money deposited will be treated as part of Security Deposit. The Security Deposit shall be released on successful completion of the defect liability period. The security deposit shall be released in full only if all the required maintenance and / or repairs have been carried out by the Contractor in timely

manner, to the complete satisfaction of the Engineer. In the event of failure of the Contractor to properly remedy the defects, the security deposit shall be released with appropriate deduction.

The work shall be completed within **10 days** from the date of issue of Work Order / Letter of Acceptance. GSIDC reserves the right to accept or reject any or all the quotations in part or full without assigning any reason whatsoever.
