published in the Official Gazette,  
Series I No. 19 dated 11-08-2016.

## AMENDMENT

The Notification referred above is amended  
as below:

Clause 4 (ii) (a) is replaced and shall be  
read as "Benefit of Assured Price shall be  
provided to the coconut sold to registered  
traders to the extent of difference between  
assured rate of Rs. 12/- and the price received  
per nut by the farmer".

Clause 4 (ii) (e) is replaced and shall be  
read as "The average minimum price fixed  
per coconut will not be less than Rs. 6/- per  
nut and the maximum assured price to be

paid to an individual farmer shall not exceed Rs. 3.00 lakhs”.

Clause 4 (iii) (a) is replaced as shall be read as “Benefit of Assured Price of Rs. 125/- shall be provided to raw cashewnut sold by farmers to the extent of difference between Rs. 125/- per kg. and the price received per kg. by the farmer. The price received shall be actual price received by sale or average rate for the week notified by the Goa State Agricultural Marketing Board (GSAMB) whichever is higher. In case the rates are not notified for the week by GSAMB, the last rates as notified would be considered as rate of sale in the market.

Clause 4 (iii) (c) is added after clause 4 (iii) (b) and shall be read as The maximum limit of difference amount between the assured price of Rs. 125/- and the actual sale price below the assured price shall be Rs. 25/- per kg.

Clause 4 (vi) is replaced and shall be read as “Benefit of Assured Price of Rs. 100/- per kg. of Alendo shall be provided to Alendo sold by the grower to the extent of difference between Rs. 100/- per kg. and actual price received per kg. by the farmer from sale to co-operative societies. A maximum of 800 kgs. from one ha. of area shall be provided with the benefit.

Minimum quantity to be sold by farmer to avail benefit shall not be less than 50 kgs.

Other contents of the notification remain the same. This amendment shall come into force with effect from the financial year 2020-21 onwards.

This issues with the approval of the Cabinet conveyed vide communication No. 1/16/2020-GAD-II dated 24-04-2020 from the General Administration Department, Secretariat, Porvorim-Goa and concurrence of the Finance (Expenditure) Department vide their U.O. No. 1400068943 dated 21-04-2020.

1. Registration of Fish Trader trading in fish in the State and Registration of all Fish Vendors who are involved in selling fish in the State.
2. The registration fees for Fish Traders in the State are as follows:

Registration Fees	Rs. 2 lakhs per year
Security Deposit	Rs. 20,000/-

3. Registration fees for all Fish Vendors are as follows:

Sr. No.	Category	Fees per year
1.	Fish seller in market and any other public places	Rs. 100/-
2.	Mobile fish seller with basket on head	Rs. 100/-
3.	Fish seller with bicycle	Rs. 200/-
4.	Fish seller with two wheeler	Rs. 500/-
5.	Fish seller with three wheeler	Rs. 1000/-
6.	Fish seller with four wheeler	Rs. 5000/-
