

**NOTIFICATION**

The Government of Goa is hereby pleased to frame the following Scheme so as to amend the Goa grant of monetary incentives to the Goan youth who have joined Armed forces of the Indian Union, Scheme, 2012, published vide Notification No. 17/08/2011-IID(G) dated 18/06/2012 in the Official Gazette, Series - I, No. 14 dated 5<sup>th</sup> July, 2012 as follows namely:-

1. Short title and commencement :- (1) This scheme may be called the Goan grant of Monetary incentive to the Goan youth who have joined Armed Forces of the Indian Union, Scheme,(First Amendment) Scheme 2018. It shall come into force from the date of its publication in the Official Gazette.
2. Amendment of Clause 3.- In the Goan grant of monetary incentives to the Goan youth who have joined Armed Forces of the Union, Scheme, 2012, in Clause 3, -
  - (i) in sub clause (a), for the expression " Rs.1,00,000/- (Rupees One lakh only)," the expression Rs. 2,00,000/-(Rupees Two lakhs only). shall be substituted;
  - (ii) in sub clause (b), for the expression of " Rs.50,000/- (Rupees Fifty Thousand only)," the expression Rs.1,00,000/-(Rupees One lakh only) shall be substituted;
  - (iii) in sub clause (c), for the expression of " Rs.25,000/- (Rupees Twenty five Thousand only)," Rs. 50,000/- (Rupees Fifty thousand only) shall be substituted.

### NOTIFICATION

The Government of Goa is hereby pleased to frame the following scheme for granting monetary incentives to Goan Youth so as to encourage them to join Armed Forces of the Indian Union.

1. Short title and commencement.- (1) This Scheme may be called the Goa grant of monetary incentives to the Goan youth who have joined Armed Forces of the Indian Union, Scheme, 2012.

(2) It shall come into force from the date of its publication in the Official Gazette.

2. Definitions:- In this Scheme, unless the context otherwise requires,-

(a) "Armed Forces of the Indian Union" means Indian Army, Indian Navy and Indian Air Force but does not include Defence Security Corps, General Reserve Engineering Force, Lok Sahayak Sena and Para Military Force(PMF);

(b) "Government" means the Government of Goa.

3. Monetary Incentives to the Goan Youth.- The Government may provide the following monetary incentives to Goan youth under this Scheme.-

(a) Rs.1,00,000/- (Rupees One lakh only) to the Goan Youth who is commissioned in Armed Forces of the Indian Union through Union Public Service Commission (UPSC) as a Permanent Commissioned Officer from the National Defence Academy (NDA) or Indian Military Academy (IMA) or Naval Academy or Air Force Academy;

(b) Rs.50,000/- (Rupees Fifty thousand only) to the Goan youth who is commissioned in Armed Forces of the Indian Union through UPSC as Short Service Commissioned Officer from the Officers Training Academy, Naval Academy or Air Force Academy;

(c) Rs.25,000/- (Rupees Twenty five thousand only) to the Goan youth who have joined Armed Forces of the Indian Union in any rank below the Commissioned Officer.

4. Eligibility for availing the monetary incentive .- For availing the monetary incentive, the person must,-

(1) (a) get President's Commission as Permanent Commissioned Officer in the Indian Army or Indian Navy or Indian Air Force by appearing and qualifying in the entrance examination conducted by Union Public Service Commission (UPSC) for National Defence Academy or Naval Academy or Combined Defence Services examination conducted by UPSC for Indian Military Academy, Naval Academy and Air Force Academy and pass out successfully from Indian Military Academy, Naval Academy and Air Force Academy , after successfully completing pre-commissioned training, as Permanent Commissioned Officer; or

(b) get President's Commission as Short Service Commissioned Officer in the Indian Army or Indian Navy or Indian Air Force by appearing and qualifying in the Combined Defence Services Examination conducted by Union Public Service Commission for Officers Training Academy or Naval Academy or Air Force Academy and pass out successfully from Officers Training Academy or Naval Academy or Air Force Academy after successfully completing pre-commissioned training, as Short Service Commissioned Officer ; or

(c) for NCC entry scheme, appear and qualify in Service Selection Boards and passed out successfully from Indian Military Academy or Naval Academy or Air Force Academy or Officers Training Academy, after successfully completion of pre-commissioned training, as permanent commissioned officer or short service commissioned officer, on the case may be, or

(d) join Indian Army or Indian Navy or Indian Air Force as Personnel below Officer Rank after successfully completing the training and attested as Soldier, Sailor and Airman before being posted to Regiments, Corps, Services, Ships, Air Force Station, units and establishments and,-

(i) recruited through open rallies conducted by Army Recruitment Directorates or Naval Recruitment Establishment or Air Force Selection Centres; or

(ii) recruited through unit headquarter quota in various Regiments, Corps and Services of the Indian Army; or

(iii) selected through qualifying examinations conducted by Indian Army or Indian Navy or Indian Air Force for various technicians, religious teachers and tradesmen.

(2) The Personnel must be of Goan origin, or born in Goa and domiciled in the State of Goa for a minimum period of 15 years;

(3) The personnel must have joined the Armed Forces of the Indian Union on or after the date of commencement of this Scheme.

5. Procedure for claiming monetary incentives under this Scheme.- The application for monetary incentives shall be submitted to the Department of Sainik Welfare in the form appended hereto along with the following documents, namely:-

- (a) Identity Card issued by the respective services;
- (b) A certificate from the Commanding Officer certifying that the personnel is in active service in the Regiment /Unit/ Ship/Establishment;
- (c) birth certificate /residence certificate

6. Procedure for disbursement of monetary incentives.- On receipt of the application, the Department of Sainik Welfare shall send the case to the Government through Home Department for consideration and approval. After obtaining approval of the Government, the monetary incentive shall be disbursed in the form of fixed deposit for a period of 5 years in the State Bank of India, in the name of the applicant.


