2) Eligibility criteria for work at Sr. No. 01 - The Agency should have carried out atleast 2 similar type of works and should submit completion certificate issued by Govt. Dept./Public Sector for completed jobs in similar category shall be scanned and uploaded to the etendering website within the period mentioned in the Tender Notice.

TENDER SCHEDULE

1. The last date of online application is **03/11/2020 up to 15.00 hrs.**
2. The last date of online submission of tender is **03/11/2020 up to 15.00 hrs.**
3. The date & time of opening of online tender is **05/11/2020 after 10.30 hrs in the Office of the Executive Engineer, Works Division VI, PWD., Fatorda Margao.**

The online application should accompany the following documents (Scan and Upload on the e-Tender website <https://goaenivida.gov.in>):

- a) Original copy of valid Registration Certificate.
- b) Original copy of PAN Card.
- c) Original GST valid registration certificate.
- d) Copy of the system generated mail/SMS from the commercial tax Department, Government of Goa showing the latest **application reference number (ARN) generated on GST common portal www.gst.gov.in** after filing the latest returns which was due as per GST law.

- e) Original copies of valid R.C. Book, valid Insurance Certificate and Valid Fitness Certificate of the vehicle. (For Sr. No.4)
- f) The vehicles shall be registered in Tourist Category under GOA R.T.O. (For Sr. No.4)
- g) The vehicles must be in good mechanical condition. (For Sr. No.4)
- h) The Driver shall possess professional driving licence with Badge, authorised to drive transport vehicle within State of Goa. (For Sr. No.4)
- i) The GST as and if applicable will be paid extra by the hirer/department. (For Sr. No.4)
- j) The vehicle should be made available on demand as and when intended by the Department. (For Sr. No.4)
- k) The vehicle should have valid PUC Certificate during the contract period. (For Sr. No.4)
- l) In case if there is any breakdown then the agency should arrange an alternative vehicle within reasonable time as decided by the concerned officer to whom the vehicle is hired. (For Sr. No.4)
- m) The Driver of the vehicle should be well dressed in prescribed uniform and the vehicle should be maintained and kept clean and neat at all times. The Driver of the vehicle should be provided with a mobile phone and should be aware of all the routes in the State. (For Sr. No.4)
- n) Mode of Payment towards Tender Document Fee(TDF), Tender Processing Fee(TPF), & Earnest Money Deposit(EMD) to be paid online through e-Payment mode via:
 - i) National Electronic Fund Transfer (NEFT) / Real-Time Gross Settlement RTGS) / Axis Bank Over-the-counter (OTC). Tenderer requires download pre-printed Challan towards credit of ITG available on e-tender website and make its payment through any of their Bank.
 - ii) Internet Payment Gateway (Debit/ Credit Card of type VISA, MASTERCARD or RuPay).
 - iii) Net Banking: Payment can be made through the Internet Banking of Any Bank.

Note:- Any Payments made through NEEFT/RTGS/OTC will take 24 hours for its reconciliation. Hence the payments through NEFT/RTGS/OTC should be made at least TWO BANK WORKING DAYS in advance before any due date and upload the scanned copy of challans in the e-Tender website as a token of payment.

- o) The applicant should upload the scanned copy of the declaration in prescribed format (Annexure -A) giving the names of the works in hand in the above mentioned category on stamp paper of Rupees 50/-. Format available for download in the e-Tender Website.

INSTRUCTIONS TO CONTRACTORS:

- 1 **Tenderer must ensure to quote percentage figure with '+ve' sign for 'Above' , with '-ve' sign for 'Below' and simply 'zero' for 'At Par' quote in the cell meant for quoting rate/percentage in figure which appears in sky blue colour (Rupees in words will be automatically taken). Also, name of the Tenderer should be entered in respective cell.**
2. The intending Tenderer must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
3. Information and Instructions for Tenderer posted on website shall form part of bid document.
4. The bid document consisting of plans, specifications, the schedule of quantity of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen in the Divisional Office or downloaded from website <https://goanivida.gov.in>.
5. Those Tenderer not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website <https://goanivida.gov.in>.
6. The intending bidder must have / obtain a valid class-III digital signature to submit the bid.
7. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
8. It is the responsibility of the Tenderer to ensure the credit of Tender Document Fees, Tender Processing Fees and EMD into the respective receiving bank accounts of ITG via various mode of payments mentioned above, on or before last any due date and time of tender.
9. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO) & will be treated as incomplete tender & will be rejected outright. Also name of the Tenderer should be entered in respective cell.

10. The Tenderer is required to ensure browser compatibility of the computer well in advance to the last date and time for receipt of tenders. The department shall not be responsible for non-accessibility of the eTender portal due to internet connectivity issues and technical glitches at the tenderer's end.
11. The tenderer shall be responsible for the correctness and genuineness of the documents uploaded during the tender submission. Any discrepancies in the matter will be liable for rejection and suitable action.
12. No Hardcopies of the documents to be submitted in the tender box. However the lowest Tenderer shall submit attested hardcopies of documents scanned & uploaded and original copy of declaration on stamp paper, after opening of the tender.
13. **Tenders which are quoted more than 20% below amount put to tender shall stand rejected.**
14. **The bidder shall quote the amount/percentage for the work excluding GST and GST as applicable shall be paid extra on the total cost of work done.**
15. **The payment of the work done will be made subject to the availability of fund.**
16. **The Tender shall be valid for minimum period of 1 year from the date of opening.**

Incomplete applications shall be summarily rejected and right to reject any or all the tenders including the lowest without assigning any reason thereof is reserved.
