"Scheme for Tribal & Scheduled Caste Families"

Dairy Kit

Introduction.— The Scheduled Caste/Scheduled Tribe have been encouraged to take up Dairy & Poultry Farming. However, the

same has not found favour with the community because they are basically poor and do not have the infrastructure and equipments to carry on the trade. The community has on the overall remained backward due to social stigma and due to their poor financial background. Special schemes have to be allocated so that the benefits proposed by the Government reach the beneficiaries.

The scheme gives them equipments of dairy use required by a Dairy farmer to conduct his business.

Objectives.—

- ★ To provide assistance to the backward classes.
- ★ To provide equipment and utensils to help in the Dairy farming.

★ To encourage the tribal population, Scheduled Caste to go in for Animal Husbandry activities.

★ The assistance is a one time assistance per family.

Eligibility.—

Pattern of Assistance.— A kit will be provided to each eligible beneficiary free of cost.

★ The proposed beneficiaries/farmer should have at least one milch animal (Local Cow/Bufaloes).

Items of general use of a Dairy farmer will be given to the farmers as assistance.

★ Scheduled Caste/Scheduled Tribe certificates from Sarpanch or Mamlatdar.

The total value of items given shall not exceed Rs. 5000/-. Each family is entitled to one kit only. The items from the kit shall consist of ghamella, steel bucket, steel cans, steel vessels, spade, brush, steel pot, feeding trough and a storage tank for storage of water.

★ Xerox copy of Ration Card duly certified by Gazetted Officer.

Read: Government Notification No. 1/10/2005 dated 6-6-2012, published in the Official Gazette, Series I No. 10, dated 7-6-2012.

The Government of Goa is hereby pleased to amend the Goa Value Added Tax based subsidy on H.S.D. Oil consumed by Fishing Vessels Scheme, 2012, published in the Official Gazette, Series I No. 10 dated 7-6-2012, vide Notification No. 1/10/2005-FSH dated 6-6-2012, as follows:—

1. *Short title and commencement.*— (1) This Scheme may be called the Goa Value Added Tax based subsidy on H.S.D. Oil consumed by Fishing Vessels (Amendment) Scheme, 2012.

(2) It shall be deemed to have come into force from 1st day of April, 2012 onwards.

2. *Amendment of Clause 7.*— In Clause 7 of the Goa Value Added Tax based subsidy on H.S.D. Oil consumed by Fishing Vessels Scheme, 2012:—

(i) in sub-clause (1), for the expression “based on the number and capacity of fishing vessels in the Co-operative Society”, the following expression shall be substituted, namely:—

“based on the number and capacity of fishing vessels in the Co-operative Society, including added quota authorized by the Department for individual beneficiary from other authorized outlet based on H.P. of vessel used, as follows:—

(ii) in sub-clause (2), for the expression “based on the capacity of each fishing vessel and the number of fishing trips the vessel makes”, the following expression shall be substituted, namely:—

“based on the capacity of each fishing vessel and the number of fishing trips the vessel makes, including added quota authorized by the Department for

individual beneficiary from other authorized outlet based on H.P. of vessel used, as follows:—

(iii) after sub-clause (10) the following sub-clause shall be inserted, namely:—

sub-clause (11) “The societies shall collect from every member, the statement of annual returns filed alongwith statement of Account for the preceding year for claiming the VAT subsidy and submit alongwith the claim”.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Goa hereby makes the following rules to regulate the recruitment to the Group ‘C’, Non-Ministerial, Non-Gazetted post in the Directorate of Art & Culture, Government of Goa, namely:—

1. *Short title, application and commencement.*— (1) These rules may be called the Government of Goa, Directorate of Art & Culture, Group ‘C’, Non-Ministerial, Non-Gazetted post, Recruitment Rules, 2013.

(2) They shall apply to the post specified in column (1) of the Schedule to these rules (hereinafter called as the “said Schedule”).

(3) They shall come into force from the date of their publication in the Official Gazette.

2. *Number, classification and scale of pay.*— The number of posts, classification of the said post and the scale of pay attached thereto shall be as specified in columns (2) to (4) of the said Schedule:

Provided that the Government may vary the number of posts specified in column (2) of the said Schedule from time to time subject to exigencies of work.

3. *Method of recruitment, age limit and other qualifications.*— The method of recruitment to the said post, age limit, qualifications and other matters connected therewith shall be as specified in columns (5) to (13) of the said Schedule.

4. *Disqualification.*— No person who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service:

Provided that the Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. *Power to relax.*— Where, the Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6. *Saving.*— Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for Scheduled Castes and other special categories of persons in accordance with the orders issued by the Government from time to time in that regard.

In exercise of the powers conferred by article 15 of the Legislative Diploma No. 1984 dated 14-4-1960, the Government of Goa hereby makes the following rules so as to further amend the IPA (Provedoria) Lottery Rules, 1979, namely:—

1. *Short title and commencement.*— (1) These rules may be called the IPA (Provedoria) Lottery (Second Amendment) Rules, 2013. (2) They shall come into force from the date of their publication in the Official Gazette.
2. *Amendment of rule 7.*— In rule 7 of the IPA (Provedoria) Lottery Rules, 1979, in sub-rule (ii) against the Serial No. (2) for the words “Collector of Goa or his representative”, the words “Collector of North Goa or his representative not below the rank of Deputy Collector” shall be substituted.
