## “GOPAL RATNA AWARD SCHEME”

Department of Animal Husbandry & Veterinary Services

## Notification

1-1(23)/AHVS/Gopal Tatna/16-17/903

The following Gopal Ratna Award Scheme approved by the Government is published for the general information of the public.

*Introduction.*— The Government of Goa has designed this scheme in order to honour the eminent personalities in the field of Dairy Farming. This scheme intends to appreciate the achievement of Dairy Farmers for highest individual milk production by undertaking scientific Dairy Farming in the State of Goa and encourage youth to take up Dairy Business.

*Objectives.*— (1) To honour the eminent personalities in the field of Dairy Farming.

(2) To felicitate and appreciate the dairy farmers for achieving highest milk production by undertaking scientific Dairy Farming in the State.

(3) To encourage the dairy farmers to undertake Dairy activities as a Business.

(4) To make State self sufficient in milk production.

*Eligibility.*— (1) Any individual dairy farmer, who has given extraordinary contribution in the field of dairy farming by achieving highest milk production in the State, shall be eligible to receive “Gopal Ratna Award” under this scheme.

(2) The scheme applies to dairy farmers from Goa who shall be the members of Dairy Co-operative Society/Bachat Gat/Self Help Group, registered with the concerned Department.

(3) The Individual Goan dairy farmer has to register his dairy farm with the department of Animal Husbandry and Veterinary Services through the respective Area Officers of Veterinary Dispensary/Hospital.

(4) The dairy farmer shall maintain and submit the record showing details of number of animals, stage of lactation of each animal, milk yield, date of calving, address of cattle shed etc.

(5) He should be a bonafide resident of Goa for at least preceding five years, own cattle shed with milch animals in the State of Goa.

(6) Any dairy farmer intending to apply for the Gopal Ratna Award shall produce evidence of his membership from a registered Dairy Co-operative Society/Bachat Gat/Self Help Groups, as required by the Department of Animal Husbandry & Veterinary Services.

(7) No Award shall be presented posthumously under this scheme. However if death of the applicant occurs after submission

of the application and if he/she qualifies for the award then the award may be considered for posthumous presentation to his/her legal heir.

(8) He shall produce and pour minimum 1 lakh litres of milk in the preceding year (April to March) with minimum average of 250 litres of milk per day, to the Dairy Co-operative Society/ /Bachat Gat/Self Help Group.

*Nature of Assistance.*— The eligible selected dairy farmer shall be honored with “Gopal Ratna Award” constituting a Certificate of appreciation, Memento and cash prize of Rs. 1 lakh only.

*Procedure.*— (1) The eligible applicant shall apply for the award through the concerned Area Officer of the Department in prescribed format of application.

(2) On verification of the content, the Area Officer shall recommend the same to the Director of AH & VS, Panaji-Goa for further necessary action.

(3) On receipt of the application from the eligible applicant they will be scrutinized by the Task Force Committee constituted for the purpose by the Government.

(4) After scrutiny of the application, the Committee shall visit the selected applicant and also at the related Dairy Co-operative Society/Bachat Gat/Self Help Group, for the necessary confirmation of the records.

(5) The Task Force Committee, after complete scrutiny and confirmation of the information given by the applicant shall recommend the name of the Awardee for necessary approval by the Department.

(6) On approval from the Department of AH & VS the Gopal Ratna Award will be declared and conferred upon the selected beneficiary on Independence Day i.e. 15th August at the hands of Honourable Chief Minister of the State.

*Committee.*— For better implementation of the scheme the Government shall constitute a Committee of the members which shall meet as and when required and shall consider the recommendation received from the field Area Officer of the Department.

*Felicitation of eligible Awardee.*— (1) Once recommendation is received from the Committee the Director of Animal Husbandry & Veterinary Services shall obtain the acceptance of the concerned milk producer to receive the “Gopal Ratna Award”.

(2) After obtaining such acceptance from the respective milk producer the Department shall obtain due approval of the State Government for awarding the said Awardee at the hand of Hon’ble Chief Minister of the State on Independence Day i.e. on 15th August.

*Framing of Guidelines.*— For better implementation of the scheme Government may change guidelines from time to time if required.

*Relaxation.*— The Government is empowered to relax all or any of the clause provided in the scheme, if found deemed fit for reason to be recorded.

*Interpretation.*— If any question arises regarding interpretation of clause, word, expression on entire scheme, then the decision about the interpretation shall be with the Government.

*Redressal of Grievances and Dispute.*— If any grievances arise out of implementation of this scheme the Secretary for Animal Husbandry shall hear and decide such matter and the decision of the Secretary for Animal Husbandry in this regard shall be final.



The following draft regulations which are proposed to be made under sub-sections (1) and (2) of section 4 of the Goa (Regulation of Land Development and Building Construction) Act, 2008 (Goa Act No. 6 of 2008) (hereinafter referred to as the “said Act”), so as to further amend the Goa Land Development and Building Construction Regulations, 2010, are hereby pre-published as required by section 5 of the said Act for information of the persons likely to be affected thereby and notice is hereby given that the said draft regulations will be taken into consideration by the Government on the expiry of a period of 30 days from the date of publication of this notification in the Official Gazette.

All objections and suggestions to the said draft regulations may be forwarded to the Chief Town Planner, Town and Country Planning Department, 2nd Floor, Dempo Tower, Patta Plaza, Panaji, Goa, before the expiry of the said period of 30 days, so that they may be taken into consideration at the time of finalization of the said regulations.

**DRAFT REGULATIONS**

In exercise of the powers conferred by sub-sections (1) and (2) of section 4 of the Goa (Regulation of Land Development and Building Construction) Act, 2008 (Goa Act No. 6 of 2008), and all other powers enabling it in this behalf, the Government of Goa hereby makes the following regulations so as to further amend the Goa Land Development and Building Construction Regulations, 2010, namely:—

1. *Short title and commencement.*— (1) These regulations may be called the Goa Land Development and Building Construction (Amendment) Regulations, 2016.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. *Amendment of regulation 2.*— In regulation 2 of the Goa Land Development and Building Construction Regulations, 2010 (hereinafter referred to as the “principal Regulations”),—

(i) for clause (16), the following clause shall be substituted, namely:—

“(16) “Balcony” means a floor projection or recess beyond internal or external wall having handrail or balustrade or parapet at least on one side, open either to internal courtyard or external air space or sitting out place. The said opening may be provided with a grill or sliding glass panel shutters;”;

(ii) in clause (43), for sub-clause (a), the following sub-clause shall be substituted, namely:—

“(a) Area of balconies, provided they are at a minimum clear height of 2.25 meters from the ground level;”;

(iii) in clause (63),—

(a) after sub-clause (b), the following sub-clause shall be inserted, namely:—

“(bb) Balcony projection shall be permitted to the extent of 1.5 meters and length of the balcony shall be limited to half the perimeter of the building. Balcony projection of 3.00 meters shall be allowed only when the balcony immediately above is at least 6 meter above and length of such above balcony is limited to half the perimeter of the building. Any balcony area more than half the perimeter of building shall be counted in FAR;”;

(b) for sub-clause (q), the following sub-clause shall be substituted, namely:—

“(q) Terraces at intermediate floors not more than 3.00 meters in depth and having a roof at over 6 meters height. Total of such intermediate terraces shall not exceed 10% of FAR proposed;”.

3. *Amendment of regulation 3.*— In regulation 3 of the principal Regulations, for the title, the following title shall be substituted, namely:—

“Procedure and Requirements for Securing Development Permission, Sub-division permission, Technical Clearances and Completion Certificate/Occupancy Certificate.—”.

4. *Amendment of regulation 4.4.1.*— In regulation 4.4.1 of the principal Regulations, for the existing Note, the following Note shall be substituted, namely:—

“*Note:* Whenever any use, other than residential, is proposed in S1, S2, S3 or S4 zone/ /Settlement zone, the front set-back shall be minimum 5.00 meters if the plot is located on a road having right of way between 8.00 meters to 10.00 meters.”.

5. *Amendment of regulation 4.4.2.*— In regulation 4.4.2. of the principal Regulations, for clause (a), the following clause shall be substituted, namely:—

“(a) In plots having minimum width of 15.00 meters, within Municipal areas, the building may be allowed, with the side set-backs less than those specified in Table-IV and limited to a minimum of 1.50 meters, provided that no light and ventilation is taken from that side. However, in such Municipal areas where building in adjoining plot or building existing within the applicant’s plot, is touching the boundary, the building may be allowed to touch the boundary or keep 1.50 meters or less on one or both sides, provided that no light and ventilation is taken from that side.”.

6. *Amendment of regulation 4.11.*— In regulation 4.11 of the principal Regulations, for clause (c), clause shall be substituted, namely:—

“(c) If any property is made accessible by an access through a property of different owner by his voluntary consent, the area used for such access shall not be deducted from the effective area of the plot in which it is provided, for the purpose of coverage and FAR calculations provided that the width of such access is 3.00 meters or more and has concurrence of the Authority/Council/ /Panchayat.”.

7. *Amendment of Regulation 5.*— In regulation 5 of the principal Regulations, for clause (a), the following clause shall be substituted, namely:—

“(a) When a plot, having an area of more than 4000M<sup>2</sup> but less than 20000M<sup>2</sup>, is used for construction of building/group of buildings, an open space, as per the provisions in sub-division Regulations (12) shall be provided, in addition to the parking requirements. However, for calculating the coverage and FAR, the area of the entire plot, inclusive of the open space, shall be taken as effective plot area. However, this provision shall not be applicable to single family dwelling unit.”.

8. *Amendment of Regulation 6A.3.1.*— In regulation 6A.3.1 of the principal Regulations,—

(a) for clause (i), the following clause shall be substituted, namely:—

“(i) Uses such as retail trade, banks, post offices, administrative offices, tailoring shops, laundry, hair cutting saloons, beauty salons, IT/ITES establishments, kindergarten/crèche, abutting on main street and professional offices including IT/ITES shall be permitted as auxiliary to the main use:

Provided, that the total covered area occupied for such uses, shall not exceed 50% of the proposed covered area, if the property derives access from a road having 8.00 meters right of way or more:

Provided further that if more than one building is proposed, then all the proposed area for commercial use as above, may be located either in one building or more than one buildings, as desired by the owner.”.

(b) for clause (v), the following clause shall be substituted, namely:—

“(v) In case of group housing, the commercial use may be allowed in one or more buildings on upper floors restricted to 50% of the proposed coverage, provided building is abutting the public road.”.

9. *Amendment of regulation 6A.4.*— In the regulation 6A.4 of the principal Regulations, in Table-VIII, for all the entries under the word “COMMERCIAL”, the following shall be substituted, namely:—

“COMMERCIAL:

10. *Amendment of regulation 12.4.*— In regulation 12.4 of the principal Regulations, for clause (b), the following clause shall be substituted, namely:—

“(b) The open spaces can be provided in more than one parcel. However, the area of each such parcel shall not be less than 500 square meters and the minimum length of any side shall not be less than 15.00 meters. (In case of odd shaped/irregular shaped plots, the length may be relaxed to 13.00 meters). Further, in case of triangular open space/any open space having irregular shape, the minimum dimension shall be that of a circle, having 15 meters diameter, inscribed within such an irregular shape (refer sketch No. 7).”.

11. *Amendment of regulation 12.8.*— For regulation 12.8 of the principal Regulations, the following regulation shall be substituted, namely:—

“12.8 *Amalgamation of sub-divided plots.* In case where sub-divided plots are amalgamated, except for those in Industrial zone Goa Industrial Development Corporation’s plots, the FAR permissible shall be reduced by 20% of the permissible FAR in respective zone.”.

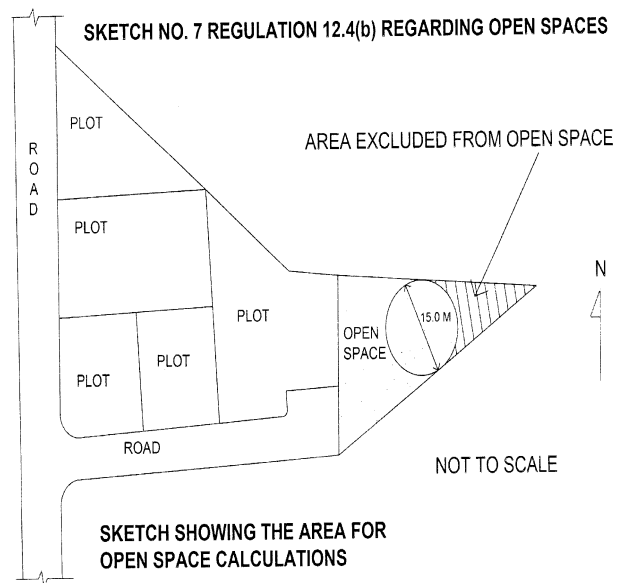
12. *Insertion of new regulation 14.1.5.*— After regulation 14.1.4 of the principal Regulations, the following regulation shall be inserted, namely:—

“14.1.5. *Sewerage Treatment Plant:* Sewerage Treatment Plant is mandatory for residential complexes having 40 flats/ residential units and above.”.

13. *Amendment of Annexure XIII.*— In Annexure XIII of the principal Regulations, in clause (2), for item (xii), the following item shall be substituted, namely:—

“(xii) The payment of Rs. 20,000/- per square meter for additional FAR shall be deposited within 30 days of issue of demand note for payment.”.

14. *Insertion of sketch No. 7.*— After sketch No. 6 of the principal Regulations, the following sketch shall be inserted, namely:—
