ORDER

UNDER SECTION 144 OF THE CODE OF CRIMINAL PROCEDURE OF 1973

WHEREAS, it has been brought to the notice of the undersigned by the Director of Animal Husbandry and Veterinary Services of Government of Goa that there is confirmation of Avian Influenza (H5N1) in Chicken in State of Maharashtra and Karnataka;

AND WHEREAS, on perusal of the facts brought to light by the Director of Animal Husbandry & Veterinary Services, I am of the considered opinion that there is a serious risk to the health of the people in South Goa District if the transportation and entry of birds and eggs from Maharashtra and Karnataka States are not stopped forthwith;

NOW THEREFORE, I, Surendra F. Naik, Additional District Magistrate, South Goa District, in exercise of the powers conferred upon me by Section 144 of the Code of Criminal Procedure 1973, do hereby prohibit the transportation and entry of birds and eggs from Maharashtra and Karnataka States into South Goa District either directly or indirectly.

This order shall come into force with immediate effect till further orders.

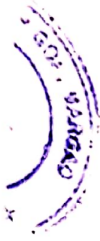
As notice cannot be served individually on all concerned, the order is hereby passed ex-parte.
