Condemned vehicle shall be available for inspection during the above period as per details of location mentioned in the tender Catalogue.


- a) E.M.D. will be at the rate of 25% of the quoted bid value in case of disposal of vehicle. The same shall be in the form of Pay Order / D.D. / D.C.R. of any Scheduled Bank drawn in favour of the **Director Department of Information Technology, 2<sup>nd</sup> Floor, IT HUB, Altinho, Panaji - Goa**, payable at Panaji and is to be enclosed by all the bidders along with their offer.
- b) The balance 75% of highest bid value of the lot should be paid by the bidder within 7 days from the date of issue of sale letter/acceptance letter by the Department to the successful bidder.

This balance payment shall also be in the form of pay Order/D.D. /D.C.R. of any scheduled bank.

The successful bidder shall lift the vehicle within 3 weeks of receiving intimation letter/delivery order from Department and failure the same, than the amount deposited as per Clause (a) and (b) shall stand forfeited.

GST shall be payable on disposal of condemned vehicle.
