ORDER

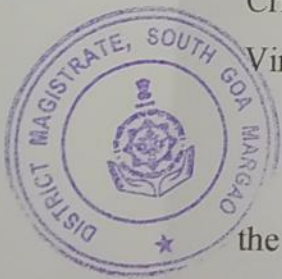
Under Section 144 of the Code of Criminal Procedure of 1973

WHEREAS, a surge in COVID-19 cases is being witnessed in Goa and other parts of the country, and the situation might further aggravate due to public gatherings and active interactions along with high positivity rate;

AND WHEREAS, in order to contain the spread of the said pandemic, certain measures are required to be taken to prevent the further spread of the disease;

AND WHEREAS in my considered opinion, there is sufficient ground for proceeding under sub section (1) of section 144 of Code of Criminal Procedure, 1973 to take preventive steps to contain the spread of Virus by restricting public gatherings and activities;

AND WHEREAS, I am satisfied that the circumstances do not permit the serving, in due time, of the notices individually upon the persons against whom this order is directed and therefore, under the powers vested in me under sub section (2) of Section 144 of the Code of Criminal Procedure, 1973, I hereby pass the order ex-parte;



NOW, THEREFORE, I, Ruchika Katyal, IAS, District Magistrate, South Goa District, in exercise of the powers conferred upon me by Section 144 of the Code of Criminal Procedure 1973, direct that the following activities shall be prohibited or restricted in the District of South Goa, till further orders:

1. No shops/establishments to remain open between 10 pm to 6 am, except industries/factories and other essential offices/utilities such as government offices and PSUs, local bodies, medical and health facilities, chemists, groceries/eatables, restaurant kitchen, hotels, public and private transport, Print and Electronic media, Telecommunication and Internet services, banks, insurance, ATMs, Petrol Pumps, LPG cylinder services.
2. The following establishments may run, but with less than 50% capacity
 - a. bars/restaurants;
 - b. river cruises/waterparks/entertainment parks;
 - c. gym/spa/massage parlours;
 - d. cinema halls, theatres, multiplexes;
 - e. casinos;
 - f. buses used as public transport.
3. The following establishment/facilities/events shall remain closed till further orders
 - a. swimming pools;
 - b. schools, Colleges, educational and coaching institutions, except for examinations of college students,
 - c. religious places for the public, however the custodian of such establishments may carry out regular activities.
 - d. social/political/sports/entertainment/academic/cultural functions and other congregations, except for
 - events with the permission of the Government
 - marriages with 50 persons or less with permission from DM/SDM and
 - cremation with less than 20 persons,



- e. gathering of five or more persons at public places, except for official functions or with permission from DM/SDM;

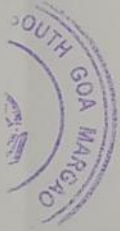
All non-government employers are also advised to actively plan and promote work from home for the employees working in their shops/ establishments/factories etc..

Any person contravening this order shall be punishable under Section 188 of the Indian Penal Code and Section 51 to 60 of the Disaster Management Act, 2005.

This order comes into force from 0000 hrs of 22 April 2021 (intervening midnight of 21st and 22nd April 2021).

This Order supersedes the Order No. 37/19/2020/L&O/MAG/3837 dated 7/4/2021 and Order No. 37/19/2020/L&O/MAG/4090 dated 17/4/2021.
