1. The last date of online application/submission is **01/07/2021** upto **15:00 hrs.**
2. The date & time of opening of e-tender is **02/07/2021** at **11:00 hrs.** in the Office of the Director, Department of Civil Supplies and Consumer Affairs, First Lift, Second floor, Junta House, Panaji-Goa.

The online application should accompany the following documents (Scanned and Uploaded on the e-Tender website):

- a. Attested copy of valid License issued by Directorate of Agriculture, License to Stock and use insecticides and pest control operations issued by Government of Goa
- b. Attested copy of GSTIN Number
- c. Attested copy of PAN Card
- d. Attested copy of work orders of previous works done for Curative, Prophylactic Treatment and Rodent Control Measures of foodgrain godowns.
- e. Mode of Payment towards Cost of the e-Tender Document, EMD & Tender Processing Fee: To be paid online through e-payment mode via NEFT/RTGS/OTC/debit card/credit card facility/net banking with pre-printed challans available on e-tendering website and directly credit the amount to ITG account as generated by challans for NEFT/RTGS/OTC.

INSTRUCTIONS TO BIDDERS

1. The intending bidder must read the terms and conditions of tender document carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
2. Information and Instructions for bidders posted on website shall form part of bid document.
3. The bid document consisting of specifications, the schedule of quantity of foodgrains and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website **<https://goaenivida.gov.in>**
4. Those bidders not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.
5. The intending bidder must have./ obtain a valid Class-III digital signature to submit the bid.
6. On opening of tender, the contractor can login and view the bid opening process and he will receive the competitor bid sheets.
7. Bidder must ensure to quote rate of each item.
8. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO) & will be treated as incomplete tender & will be rejected outright. Also name of the bidder should be entered in respective cell. .
9. The bidder shall be responsible for the correctness and genuineness of the documents uploaded during tender submission. Any discrepancies in the matter will be liable for rejection and suitable action.

Incomplete applications shall be summarily rejected and right to reject any or all the tenders including the lowest without assigning any reason thereof is reserved.
