The said entrance test is scheduled on **12<sup>th</sup> September, 2021 (Sunday)**.

The candidates who have passed XII Std. (10 + 2) examination with 50% marks in Physics, Chemistry, Biology/Biotechnology and English taken together shall be eligible for admission. Further, the candidate should have also appeared for **NEET (UG) - 2021**.

The concerned candidates should note that all the admissions for B.V.Sc. & A.H. Degree Course under this University shall be made on the basis of score obtained by the candidate in the **NEET (UG) - 2021** entrance examination conducted by National Testing Agency.
