## CIRCULAR

Vide letter No.Insp-I/62/2021, dated 25/08/2021 the Registrar (Inspection-I), High Court, Appellate Side, Bombay, has communicated to this Court that the Hon'ble Administrative Judges Committee have resolved that;

- All the District and Subordinate Courts in the North-Goa District shall not take more than 25 matters in each session till the end of September, 2021.
- 2) No adverse orders may be passed in the absence of the Advocates and parties not appearing when their matter is called on for consideration.
- Disposal norms for the Judicial Officers of such Courts are exempted during this period.

Therefore, all the District and Subordinate Courts in the North-Goa District are hereby directed to take necessary steps for compliance of the above directions with immediate effect.
