(3) Any candidates having cold/cough symptoms may please get themselves checked before appearing for the exam. Further, COVID-19 positive candidate, if any, should whatsapp his/her COVID-19 positive report and other details viz. full name, Seat No, & center of Examination to the mobile No 76200259015 in order to direct/assist him/her to the separate arrangements made in this regard.

- (4) Only candidate wearing mask will be allowed entry in the examination hall as per the SOPs issued by the Government relating to Covid-19 pandemic.
- (5) The Candidate should download, print and carry the Hall ticket at the examination hall along with any one of the following photo identification proof in original, without which the candidate shall not be allowed to answer the examination.
- (i) Voter ID
 - (ii) Postal ID
 - (iii) Valid Passport
 - (iv) Valid Driving License
 - (v) Aadhar Card, or
 - (vi) Any other Government issued photo ID proof.
- (6) The candidate shall only carry **ball point pen (Blue/Black)** at the examination hall. Books and electronic devices including mobile phones, cameras, calculators, etc., are strictly prohibited in the examination hall.
- (7) The candidate shall follow all the instructions given by the Invigilator/Officer-in-Charge of the Examination hall during the conduct of the examination. Violation of any instructions and/or practice of any unfair means in the examination center will make the candidate liable to be disqualified from answering the examination and for selection to the post. Also, the candidate will be liable for disciplinary action under the appropriate rules, if he/she already is in Government service.
- (8) The candidate shall note that mere fact of his/her admission to the written exam does not imply that the detail in his/her application has been accepted by this office. If, at any stage, it is found that the candidate does not satisfy the eligibility criteria as given in the advertisement and the Recruitment Rules, the candidature of the candidate shall stand terminated.
