Brief Guidelines for Expression of Interest for

“Empanelment of eligible Manufacturers/Dealer of Solar Grade Mirror for promotion of Concentrated Solar Technologies Works & Project Development”

1- Objective: Energy efficiency is an important accompaniment to renewable energy. Energy savings should be realized before implementing new-generation capacities. To raise awareness of the technical and economic potential of the Concentrated Solar Technologies (CST_ we need to create reference systems. The limiting factor of many CST is the space for mounting the collector field. Collectors include mirrors or reflecting surfaces that reflect the incoming radiation onto a focus, where the solar receiver is placed. The collectors' efficiency strongly depends on the reflector material. Mirrors have an essential role in various solar thermal technology applications.
