Government of Goa is pleased to notify that the name of the self employment scheme being implemented by EDC Ltd., which was notified vide Notification No. 2-6-2013-FIN(DMU) published in the Official Gazette, Series I No. 26 dated 25th September, 2014, under the changed name of Dr. Verghese Kurien Rojgar Yojana" is hereby reverted back to its original name i.e. "Chief Minister's Rojgar Yojana", with immediate effect.

Henceforth, the said scheme would be named as the "Chief Minister's Rojgar Yojana". In the intervening period, i.e. from 25th September, 2014 till the publication of this notification, any references made to the said scheme as Dr. Verghese Kurien Rojgar Yojana or VKRY in any notification, Scheme, Order, legal document, Circular, correspondence etc., shall be deemed to read as the Chief Minister's Rojgar Yojana.

The following bill which was introduced in the Legislative Assembly of the State of Goa on 14th January, 2016 is hereby published for general information in pursuance of Rule – 138 of the Rules of Procedure and Conduct of Business of the Goa Legislative Assembly.

*further to amend the Goa, Daman and Diu Town and Country Planning Act, 1974 (Act 21 of 1975).*

Be it enacted by the Legislative Assembly of Goa in the Sixty-sixth Year of the Republic of India, as follows:—

1. *Short title and commencement.*— (1) This Act may be called the Goa Town and Country Planning (Amendment) Act, 2016.

(2) It shall be deemed to have come into force on the 14th day of November, 2015.

2. *Insertion of new section 42A.*— After section 42 of the Goa, Daman and Diu Town and Country Planning Act, 1974 (Act 21 of 1975), the following section shall be inserted, namely:—

"42A. *Setting up of Eco Tourism Activities.*— Notwithstanding anything contained in this Act, or the Regional Plan, Outline Development Plan, or a Comprehensive Development Plan or a Land Use Plan prepared under this Act, or in any of the provisions of the Goa Land Revenue Code, 1968 or any other law for the time being in force, an Applicant who desires to set up any Eco Tourism activity permitted in the Eco Sensitive Zone Notification, in Eco Sensitive Zones declared under the Environment Protection Act, 1986 and the Rules framed there under by the Ministry of Environment and Forest, Government of India, shall not be required to obtain any conversion of land, or any change of zoning or change of land use or any change of land either under this Act or any other maps or plans finalised there
