In partial modification to the above read Notifications, Government of Goa, further amends the “Chief Minister’s Rozgar Yojana (CMRY)” (hereinafter referred to as the “Scheme”) read above as follows:—

1. In clause (1) of the scheme, sub-clause (e) shall be substituted by the following:—

(e) *Defaulter/Non Eligibility*: Should not be a defaulter to any nationalized bank/ financial institution/co-operative bank. Further, a person already assisted under other subsidy linked scheme, except the person who has availed assistance under the “Debt Relief Scheme for mining affected borrowers of Financial Institution” of Mines Department, Government of Goa will not be eligible under this scheme, unless otherwise relaxed/specified.

This notification shall be deemed to have come into effect from the date of its publication.
