NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited for the work **"To prepare a Master plan for Mormugao Constituency SH: Swimming pool – Furniture work"** from the eligible bidders. The sealed quotations shall be received **upto 15:00 hours on 10th December 2021** and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is **Rs.9,43,346.40 (Rupees Nine Lakh Forty Three Thousand Three Hundred Forty-Six and Paise Forty only)**.

The Schedule of Quantities including the description of the item is furnished in **ANNEXURE-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **ANNEXURE-I** while submitting the quotation. The Contractor shall include all the taxes as applicable in the rates quoted for various items specified in the bill of quantities except for Goods & Service Tax (GST) which will be paid as per the prevailing applicable rate during execution of work. Bidders will ensure that full benefit of input tax likely to be availed by them is duly considered while quoting rate. All the pages of **ANNEXURE-I, ANNEXURE-II and ANNEXURE-III** shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs.18,870.00** (Rupees Eighteen Thousand Eight Hundred and Seventy Only) in the form of Demand Draft from the Nationalised / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

Bidders may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be **9th December 2021 upto 16:30 hours**.

In case of delay, the successful bidder shall be liable to pay to the Employer an amount of **Rs.2,516.00** (Rupees Two Thousand Five Hundred and Sixteen only) per day as Liquidated Damages for default for every day. However, such total amount as Liquidated Damages shall not exceed 10% of the original quotation price.

The Defects Liability Period for the work under reference shall be 3 years.


The Security Deposit shall be collected by deductions from the running bills/final bill at the rate of 5% and the Earnest Money deposited will be treated as part of the Security Deposit. Earnest Money shall be adjusted first in the security deposit and further recovery of security deposit shall commence only when the upto date amount of security deposit starts exceeding the earnest money. A sum of 5% of the gross amount (including taxes) of the bill shall be deducted from each running bill/ final bill of the Contractor till the sum along with the sum already deposited as Earnest Money will amount to Security Deposit of 5% of Contract Price of the work.

50% of the security deposit shall be released after successful completion of 1st year of defects liability period. Further 25% of the security deposit shall be released after successful completion of 2nd year of defects liability period and balance 25% of security deposit shall be released on pro-rata basis every year till the balance defect liability period is over.

The above mentioned amounts shall be released in full only if all the required maintenance and/or repair have been carried out by the contractor in a timely manner, to the complete satisfaction of the Engineer/Employer. In the event of the failure of the contractor to properly remedy the defects, the security deposit amount shall be released with appropriate deductions.

The work shall be completed within 30 days from the date of issue of Letter of Acceptance/Work Order.

GSIDC reserves the right to accept or reject any or all the quotations/in part or full without assigning any reason whatsoever.
