PUBLIC NOTICE

WHEREAS, Ministry of Railways (South Western Railway Construction Organization) Government of India vide its notification S.O. 1844 (E) dated 09/06/2020 issued under Sub Section (1) of Section 20A of the Railways Act at 1989 (24 of Bravity published in Extraordinary Gazette of India dated 10/06/2020), has declared its intention to the Notification for the special Railway Project namely “ Londa Vasco Road over Bridge in lieu of level crossing No. 19 Project in State of Goa.”

AND WHEREAS, the undersigned has been authorized to function as the “ Competent Authority” under clause (7A) of Section 2 of the said Act vide S.O. 1844 (E) dated 09/06/200 published in the Extraordinary Gazette of India to hear the objections and pass the orders either to allow or disallow such Objection.

AND WHEREAS the Central Government vide notification S.O. 4043 (E) dated 30/09/2020 published in Extraordinary Gazette of India dated 30/09/2021 and Corrigendum S.O. 4518 (E) dated 28/10/2021 published in Extraordinary Gazette of India dated 29/10/2021 by Sub Section (1) of Section 20E of the Railway Act declare that the land described and shown in the following Schedule shall be acquired for executing the Special Railway Project namely Doubling of Vasco da Gama-Kulem Section of Tinaighat- Vasco da Gama in the State of Goa, construction of ROB in lieu of LC-19 at KM 82/500 – 600 between Chandor Goa and Margao Station.
