Sealed Item Rate quotations are invited from the eligible contractors/authorized dealers & service providers for the work of **“Major Maintenance work of Goa Medical College & Hospital at Bambolim, Goa SH- Servicing of HT breakers and RMUs installed in GMC”**

The sealed quotation shall be received upto 15:00 hours on 26th April 2022 and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is **Rs.3,42,000.00.**

The bidders shall submit their offer by indicating rates for the item as per the enclosed **Annexure-I** while submitting the quotation. Rates shall be inclusive of all taxes except GST. GST will be paid extra as applicable at the time of billing. The general terms and conditions are furnished in **Annexure-III**. All the pages of Annexure -I, II & III shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to Rs.6,840.00 (Rupees Six Thousand Eight Hundred Forty only) in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **Annexure-II**, duly typed/handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.
