All the expenditure on the above shall be borne from the funds of the Goa State Pollution Control Board (GSPCB).

Ministry of Environment, Forests and Climate Change issued The Noise Pollution (Regulation and Control) Rules, 2000 vide S.O. 123 (E) dated 14-02-2000. Since the year 2000, the said Rules have been further amended by five more notifications till date.

The Ambient Air Quality Standards in respect of Noise as per the Notification are as follows:-

2. Hon'ble NGT directions dated 15-03-2019 in O.A. 681/2018 has issued various directions including preparation of Action Plan for Noise Mapping/Monitoring and emphasized on remedial action to be taken to curb the noise menace and as a result streamline the process of noise mapping and monitoring in order to meet the standards prescribed in the Rules.

3. As per Section 2(c) of the Rules, the State Government has designated "Authority" vide notification No. 7/4/98/STE/DIR/Part-I/922 dated 04-12-2007 and amended the same from time to time.

4. In addition and in pursuance of the directives of the Hon'ble High Court of Bombay at Goa in MCA No. 588 of 2010 in Suo Motu Writ Petition No. 4 of 2006, the names and telephone numbers of designated authority are displayed on the website of the Department ([www.doecc.goa.gov.in](http://www.doecc.goa.gov.in)) for easy access and updated at regular intervals, for information of the public.

5. Vide Notification No. 7/4/98/STE/DIR/Part-IV/412 dated 31-07-2020 published in Official Gazette, Series II No.19 dated 06-08-2020, the State Government has directed "authority" to ensure that no audio system or public address system shall be let out/installed without being fitted with sound limiter in any Government or non-Government function in the whole of the State of Goa for outdoor functions. Annexed as Annexure "A".

6. Vide Notification No. 7/4/98/STE/DIR/Part-IV/753 dated 14-10-2020, the State Government has mentioned categorization of are areas as per the outline development plans. Annexed as Annexure "B".

#### **7. Action by the "Authority" under the Noise Rules, 2000**

The "Authority" so designated in the state as per Notifications mentioned above shall follow directives as under:-

a) A loud speaker or Public Address system or any sound producing instruments or musical instruments or sound amplifier shall not be used in open areas without the prior permission of the Authority prescribed under the Rules.

b) Persons requiring use of loud speaker have to submit application in prescribed format to the "authority" of the concerned areas at least seven

days before the date of use. The "Authority", on receipt of the said application, shall undertake enquiry, as deemed necessary and give permission indicating the conditions to be complied with. The permission may also be refused, if deemed necessary, indicating the reasons thereof. Authority shall take necessary action for ensuring that the directions indicated above are complied with and in the event of any violation appropriate action shall be taken as per provisions of the relevant Rules. The application shall be made in Form Annexed as Annexure "C" to the Deputy Collector/ Sub-Divisional Magistrate of the concerned Taluka.

c) In case of events/functions/programmes involving more than 50 participants, the application shall be forwarded by the Authority to the Goa State Pollution Control Board (GSPCB). The Applicant shall deposit a fee of Rupees 3000/event/programme/functions with the GSPCB.

d) The Pollution Control Board will prepare a report in the Format Annexed as "Annexure D". The GSPCB will forward the report to the Department of Environment and the Department will than after assessment issue recommendation to the Authority i.e. Collector/Deputy Collector.

e) No Public Address System loudspeaker or any sound producing instrument or a musical instrument or a sound amplifier shall be sold purchased, supplied/used by any manufacture/ dealer/shopkeeper without the installation of Noise Limiter in outdoor areas. These sound producing instruments will not be permitted for use at night time during 10 p.m. to 6 a.m. except either in indoor setup or during any public emergency or during the 15 festive days so notified by the State Government.

f) In case of Open Air venues for marriages/ weddings/functions/parties etc. each such venue shall install online noise level monitoring system and shall also provide a display board along the periphery of the venue so as to display the noise levels recorded at the venue for the benefit of the public. Such online system shall be also connected to the GSPCB server as well as the office of the Sub-Divisional Magistrate and Office of the Deputy Superintendent of Police for the purpose of monitoring the noise levels and ensuring compliance to the Rules. The Open Air Venue Operator will submit details of the equipment installed at the venue to the concerned Sub-Divisional Magistrate in Form E and the said details will be forwarded to the GSPCB for its Inspection and comments. The Applicant shall deposit and amount of Rupees 5000 as fees to the GSPCB. The GSPCB will forward the inspection report with recommendation to the Department of Environment.



The Department of Environment will thereafter forward the report to the SDM/DM with its recommendations. Every Open Air Venue shall be assessed by the Authority annually through the GSPCB and Department of Environment.

g) Only those Diesel Generator Set which comply with the provision of the Environment (Protection) Rules, as notified by the Moefcc from time to time in respect of acoustic enclosure, noise level, certification, insertion loss and exhaust muffler shall be sold purchased, supplied/used by any manufacture/dealer/shopkeeper. The Diesel Generator Set operation shall be monitored by Authority prescribed under these Rules. The Prevalent provision is annexed as Annexure "E".

h) Under no circumstances, playing of music or using sound amplifiers, beating drums or blowing either a musical or pressure trumpets or beats or sound of any instrument, performance of any nature to attract crowds, bursting of sound emitting fire crackers, loudspeakers or Public Address systems shall be permitted in the "silence Zone: within a radius of 100 meters from any school, college, hospital & court except during the 15 Festive days so notified by the State Government, only with prior intimation to the authority concerned.

i) The peripheral noise level of a privately owned sound system or sound producing instrument shall not, at the boundary of the private place, exceed by than 5 dB (A) the ambient noise standards specified for the area in which it is used.

j) Occupant of any public space as defined shall ensure that noise emitting from any activity shall not exceed the noise limit more than 10Db(A) of the prescribed standard.

k) Due care shall be taken for ensuring that the rules are obeyed in a graceful and civil manner as far as feasible and only in case of resistance by the violators, punitive action is to be taken.

#### **8. Action by Department of Environment/Goa State Pollution Control Board:**

1) Required equipment for measuring intensity of sound shall be made available to the "Authority" by the Department of Environment.

2) The Goa State Pollution Control Board shall carry out Noise level mapping along with the Police Officials at the following locations and suggest Remedial Measures required if any based on the Noise level mapping;

##### **A. Industrial Zone:**

- a) Amona/Navelim.
- b) St. Jose de Areal Industrial Area.

- c) Loading jetties for iron ore.
- d) Sada at MPT Port.

##### **B. Commercial Zone:**

- a) Calangute/Candolim/Baga.
- b) Morjim/Mandrem.
- c) Agonda/Palolem.
- d) Mapusa Market.
- e) SGPDA Market Margao.

##### **C. Residential Area:**

- a) Government Quarters Patto.
- b) Residential Areas on Mining Transport Routes/Junction.
- c) Residential Area near Airport.
- d) Residential Area Mapusa and Margao.

##### **D. Silence Zone:**

- a) High Court Complex.
- b) Goa Medical College.
- c) Hospicio/Asilo Hospitals (District Hospitals.)
- d) School Complex Cujira.

3) The Noise level Mapping shall be extended to other areas if required on the recommendations of the District Magistrate and the locations will be selected as recommended by CPCB in their guidelines titled "Methodology for Formulation of Noise Mapping in India" annexed as **Annexure F**.

4) The Goa State Pollution Control Board shall carry out the Noise level mapping on its own or with assistance of Moefcc approved Laboratories whenever required and the expenditure incurred for the same will be reimbursed by the Department of Environment.

5) The Goa State Pollution Control Board (GSPCB) shall organize capacity building and necessary technical guidance to the officials from the Revenue Department and the Police Department. The Board will also carry out Noise Level Monitoring whenever required on the instructions of the Revenue Authorities.

6) The Department of Environment will also provide wide publicity in print and electronic media about the provision of these Rules.

##### **9) Action by Transport Department:**

- 1) The horns or other producing device on vehicles should comply with Rule 119 of the Motor Vehicles Rules. No vehicle with sound boxes or Modified exhaust should be permitted to ply. Requirement for complying with these should be

indicated in the licenses and looked into while issuing and renewing license. While appropriate legal action may be taken for the first offence committed by the driver/vehicle, in case the offence happening for the second time, route permit, wherever applicable, of such vehicle/driver shall be cancelled and sound box seized.

- 2) The Road Transport Authority/Car dealer/ Audio equipment seller shall ensure that audio system in the vehicle shall be installed with a Noise Limiter. The Noise level of any such audio system installed in a vehicle shall not exceed 75 dB(A) at 2 meters distance from the vehicle.
- 3) Penalties for the first offence will be levied in accordance to the provision of the Motor Vehicles Act. For subsequent offence action as per the provision of Section 15 of the Environment (Protection) Act, 1986 in addition to the provision of the Motor Vehicles Act and removal of audio system and accessories/confiscation.

10. Education/Higher Education Department/ Public Works Department/Other Government Department/Local Bodies/Corporations.

- a) The Education/Higher Education Department will carry out awareness among students in respect of provision of these Rules with Assistance of the Goa State Pollution Control Board.
- b) The Town and Country Planning Department/Planning and Development

Authorities, Public Works Department and other Government Departments/ Corporations shall give due consideration to Noise pollution as a parameter of quality of life and objective to ensure that the standards of Noise level meet the prescribed standards while granting permission for developmental activities.

#### 11) Scale of compensation for violation of Noise Rules:

As submitted in compliance to Hon'ble National Green Tribunal (NGT) dated 01-08-2019 in the matter O.A No. 519 of 2016 Titled; Hardeep Singh & ORS VS SDMC & ORS.

- Source of noise pollution have been identified based on provisions mentioned in the Section 2.1.
- 10-25% of the cost of instrument has been considered as compensation for violations of provisions of noise rules and repeated violators to be imposed fine which has deterrent effect.
- Accordingly compensation to be paid by the defaulter and action to be taken by the authority for violations of Noise Rules by usage of equipment like public address system, construction equipment, generator sets and music DJ system are recommended as per details given in Table 1.

**Note:**

1. Clause 5 (1): A loud speaker or a public address system shall not be used except after obtaining written permission from the authority.

2. Clause 5 (2): A loud speaker or a public address system shall or any sound producing instrument or a musical instrument or a sound amplifier shall not be used at night time except in close premises for communication within, like auditoria, conference rooms, community halls, banquet halls or during a public emergency.

3. Clause 6 (i) Playing any music or any sound amplifiers in any place covered under the silence room/area are prohibited.

4. Clause 6 (ii) Beating a drum or tom-tom or blows a horn either musical or pressure, or trumpet or beats or sounds any instrument at any place covered under the silence zone/area are prohibited.

5. Clause 6 (iii) Exhibits any mimetic, musical or other performances of a nature to attract crowds in any place covered under the silence zone/area are prohibited.

6. Clause 5 (A) (3): Sound emitting construction equipment shall not be used or operated during night time in residential areas and silence zones.

7. Sound emitting fire crackers shall not be burst in silence zone or during night time in each zone;

8. As per direction of the Hon'ble Supreme Court, following time limits are prescribed for bursting fire crackers:

Diwali: 8 p.m. to 10 p.m. Guru Purnima: 4 a.m. to 5 a.m. and 9 p.m. to 10 p.m.

New Year and Christmas: 11:55 p.m. to 12:30 a.m.

9. It may be notes that imposition of fine for fine for Notification of Rule 5A (1) falls within the purview Motor Vehicle Rules, 2019.

**Limitation of Noise rule with respect to Loudspeaker.**

1. Existing standards for loudspeaker defined under Clause 5(4) of Noise Rules, 2000 states that noise level at boundary of the public place, where loudspeaker or public address system or any other noise source is being used shall not exist 10 dB(A) above the ambient noise standards for the area or 75 dB(A) whichever is lower.

2. In order to verify compliance, ambient noise monitoring is to be carried out for 16 hours (day time) and violation of specific source of noise can be identified due to background noise. Further, as impact of the noise source, duration of which mostly varies from few seconds to few minutes gets leveled when monitoring for long duration (16 hrs.) is carried out.

3. Recently, CPCB has carried out demonstration of sound limiters and it was found that sound limiter is not full proof system and same can easily temper with. It is difficult for authorities to set limits for sound limiters in absence of source standards for loudspeakers while granting permission for public address system.

4. Source specific standards have been notified for fire crackers, generator sets, construction equipment, vehicles etc. However, Source specific standards for loudspeakers and public address system yet to be framed. In view of (i-iv) above, it is suggested that source specific standards be framed for loudspeaker and public address system with specific usage type.

**Recommendations**

1. Designated authorities defined as per Clause 2 (C) of Noise pollution (Regulation and Control) Rules, 2000 shall imposed penalties and take necessary action against defaulters as per details given in Table 1.

2. The Compensation to be paid shall be 2/3 times the original fine for the 2nd and 3rd violation respectively and permission for installation/operation of the equipment shall be withdrawn thereafter.

1) The Horns or other sound producing device on vehicles should comply with Rule 119 of the Motor Vehicle Rules. No vehicle with sound boxes or modified exhaust should be permitted to ply. Requirement for complying with these should be indicated the licences and looked into while issuing

& renewing licence while appropriate legal action may be taken for the 1st offense committed by the driver/vehicle, incase of a repeated offense, route permit, wherever applicable of such vehicle/driver shall be cancelled and sound creating device seized.

2) The Road transport authority/car dealer/Audio/Equipment seller shall ensure that audio system in the vehicle shall be installed with a noise limiter. The noise level of any such audio system installed in a vehicle shall not exceed 55 dB(A) at 2m distance from the vehicle.

3) Penalties for the first offense will be levied in accordance to the provision of Motor Vehicles Act. For subsequent offence/s action as per the provision of Section 15 of the Environment (Protection) Act, 1986 will be initiated in addition to the provisions of the Motor Vehicles Act and removal of audio system and accessories including confiscation.

The Goa State Pollution Control Board which has been constituted by the Government of Goa under Section 4 of the Water Act is deemed to be a State Board for the prevention and control of air pollution under Section 4 of the Air Act and it is empowered to exercise the powers and perform the function of the State Board for the prevention and control of air pollution under the Air act. The GSPCB be construed as an authority for the purpose of the definition as contained in Clause (c) of Rule 2 of the Noise Pollution (Regulation and Control) Rules, 2000.

Whereas, the World Health Organization (WHO) designated SARS-CoV-2 variant: B.1.1.529 (Omicron) as the Variant of Concern. The number of COVID-19 cases being reported in Goa are increasing, and the situation might further aggravate if public gatherings and active interactions is permitted unrestricted.

And whereas, the State Task Force considering the present situation examined the recommendations of the Expert Committee, which has informed that the number of hospitalization vis a vis Covid positive cases is low, the Covid positivity rate is also rapidly going up;

And whereas, in order to contain the spread of the pandemic, certain measures were undertaken and restrictions have been imposed under the Disaster Management Act, 2005 vide the Revenue Department's Order No. 1/5/29/2020-RD dated 29-12-2021. Considering the prevailing situation, the said restrictions and measures are required to be continued, while additional restrictions needs to be imposed to prevent the further spread of the disease;

And whereas, the State Government is satisfied that the State of Goa still faces threat of the spread

of COVID-19 virus in the immediate future and therefore it is necessary to take certain emergency measures to prevent and contain the spread of virus, the Government in exercise of the powers conferred under various provisions of the Epidemic Act, 1897, it is expedient to enforce certain additional measures throughout the State till further order.

Now, therefore, in exercise of the powers conferred under the Epidemic Act, 1897, the undersigned has been directed to convey that the following activities/establishment/facilities/events shall be restricted, till further order:

1. Schools shall be closed for students till 26-01-2022, however teachers to attend schools for conducting online classes;
2. Colleges and other institutions of higher educations shall be closed for students till 26-01-2022 except for the conduct of examinations, however teachers to attend schools for conducting online classes;
3. The Health department and Directorate of Education/other school authorities shall endeavor to complete vaccination of children from 15 to 18 years of age as soon as possible.
4. Public gatherings in case of indoor halls/ auditoriums/mandaps etc. shall be restricted to a maximum of 50 persons or 50% of the seating capacity or whichever is less.
5. Public gatherings in case of open spaces shall be restricted to a maximum of 100 persons.

The above restrictions is in addition of the restrictions already imposed under the Disaster Management Act, 2005 vide the Revenue department's Order No. 1/5/29/2020-RD dated 29-12-2021.

The District Collector North and South Goa are required to ensure strict compliance of these directions and take necessary action wherever required to ensure total compliance. Both the District Collectors are also empowered to issue necessary urgent clarifications etc. to remove any ambiguity or difficulty arising in interpretation and enforcement of these instructions.

Any person contravening this order shall be punishable under Section 188 of the Indian Penal Code.

In supersession of the earlier notifications issued in this regard, the Government is pleased to revise the Pattern of Assistance prescribing the following terms and conditions and the purpose for sanctioning grants to the Urban Local Bodies of Goa:-

I. Purpose for which grants may be sanctioned:

- a. Development works.
- b. Salaries to the Common Cadre staff, deputation staff and dearness allowance as per the prevailing rate to employees of Corporation/  
/Municipal Council.
- c. Honorarium to Chairperson/Vice-Chairperson and Councillors of "B" Class and "C" Class Municipal Council as prescribed.
- d. Grants for Pre-Monsoon works and workers provided for Fire services during monsoon period.
- e. Grants under special Components Plan for Schedule Caste and Schedule Tribe Development Scheme.
- f. Special Grants for infrastructure Development for ULB's.
- g. Grants to Urban Local Bodies under Finance Commissions.
- h. Solid Waste Management related works and equipments.
- i. For Capacity Building through training, workshops.
- j. Disaster management related works and equipments.
- k. Grants for land Acquisition.
- l. Execution of Court decree and Orders.
- m. Grants for payment of Government dues, statutory dues etc.
- n. Special assistance towards 60th years of Goa's Liberation.

II. Condition for release of grants.

The grants shall be released on the terms and conditions as detailed below:-

1. Urban Local Bodies desiring to avail of the Department of Urban Development benefits of grants shall submit their proposal to the

Directorate of Municipal Administration/Urban Development along with the following documents.

- a. Resolution of the Corporation/Municipality.
  - b. Certificate to the effect that the project/works has been reflected in the budget.
  - c. Projects report with full particulars.
  - d. Estimated cost along with the technical sanction from the competent authority.
  - e. Ownership documents of the property site of the project.
2. The sanction of the grants shall be subject to the availability of funds on submission of priority list works submitted by the Corporation/  
/Municipalities.
  3. The salary grants to be released in six monthly instalments.
  4. The entire amount of the grants released for salary, pre-monsoon, Fire Service and Honorarium shall be utilize within the period of one year from the date of drawal and only for the purpose for which it is sanctioned.
  5. Any portion of the salary grant which is not utilized or is not ultimately required shall be taken into account in sanctioning the subsequent salary grant in the next financial year.
  6. The entire amount of the grants released for Development works, SWM works and Disaster management works shall be utilized within a period of one year from the date of sanction and only for the purpose for which it is sanctioned and shall not be utilized for any other purpose.
  7. The grants for 60th year of Goa's Liberation will be released to ULB's in one instalment after taking administrative approval, following which the ULB's have to utilize the funds for the given purpose after following codal formalities.
  8. After utilizing/refunding the above sanctioned amount, an utilization certificate in the proforma in G.F.R. 19 is required to be furnished invariably to this Directorate within two months from the date of its utilization.
  9. The assets if any created out of the Government grants will be subject to the provision of General Financial Rules and other conditions governing the grant-in-aid.
  10. Accounts of Corporation/Municipalities shall be subject to the Audit by the Comptroller and Auditor General of India at his discretion and

by the Director of Accounts & Directorate of Urban Development.

11. The audited statements of accounts showing the expenditure incurred by the Corporation/ Municipal Council from the grants should be furnished to this Directorate within nine months after the close of the financial year together with a certificate from the Auditor to the effect that the grant was utilised for the purpose for which it was sanctioned.

12. Performance cum achievement report/specifying in detail the achievements made by the council with the Government grants should be furnished to this Directorate/Government

within six months after the close of the financial year.

13. The Assistant Accounts Officer of this office shall countersign the Grant-in-aid bills in form G.A.R.- 32 submitted by the Corporation/ Municipal Council.
