NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible bidders for the work of “*Re-construction of GPS at Vithalapur in Sanhali, Bicholim Taluka - Additional work*”. The sealed quotations shall be received *upto 15:00 hours on 05th July 2022* and the same will be opened after *15:30 hours* on the same day. The estimated cost for the work is **Rs.6,87,600.00 (Rupees Six Lakhs Eighty Seven Thousand Six Hundred only)**.

The Schedule of Quantities including the description & procedure for executing the item is furnished in **ANNEXURE-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the items as per the enclosed **ANNEXURE-I** while submitting the quotation. The Bidder shall include all the taxes as applicable in the rates quoted for various items specified in the bill of quantities except for Goods & Service Tax (GST) which will be paid as per the prevailing applicable rate during execution of work. Bidders will ensure that full benefit of input tax likely to be availed by them is duly considered while quoting rate. All the pages of **ANNEXURE-I** and **ANNEXURE-II** shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs.13,800.00 (Rupees Thirteen Thousand Eight Hundred only)** in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favor of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

The bid shall be submitted in two sealed envelopes marks as follows:

Envelope 1- E.M.D

A bid not accompanied by Earnest Money Deposit shall be rejected.

Envelope 2- Financial Bid

Original copies of Annexure-I and its corrigendum/addendum duly filled and duly signed and stamped.

The above mentioned envelopes shall be again put together in one common outer cover/envelope and sealed, superscribed in capital letters along with the title of the project.

All three envelopes shall be marked on the left hand top corner thus:

“Re-construction of GPS at Vithalapur in Sankhali, Bicholim Taluka- Additional work”

Have full name and address of the bidder written or typed on these envelopes. Indicate the contents. If all envelopes are not sealed, superscribed or submitted in any other than

mentioned format, GSIDC will assume no responsibility for the misplacement or premature opening of the bid submitted and bid may be rejected by GSIDC.

A contractor having executed similar works may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be **05th July 2022, upto 11:30 hours.**


Terms & conditions:

- The security deposit shall be collected by deduction from the bill at the rate of 5% and the Earnest Money deposited will be treated as part of Security Deposit. The Security Deposit shall be released on successful completion of 1 year from the date of completion of the work. The security deposit shall be released in full only all the required maintenance and / or repairs have been carried out by the Contractor in timely manner, to the complete satisfaction of the Engineer.

In the event of failure of the Contractor to properly remedy the defects, the security deposit shall be released with appropriate deduction.

- The work shall be completed within 45 days from the day of issue of Letter of Acceptance/ Work Order.
- The Bidder shall acquaint himself with the site and scope of work before bidding for the work.
- The Defect Liability Period shall be **1 year (One year).**

GSIDC reserves the right to accept or reject any or all the quotations in part or full without assigning any reason whatsoever.
