The following draft Rules which the Government of Goa proposes to make in exercise of the powers conferred by sub-sections (1) and (2) of section 127 of the Goa Co-operative Societies Act, 2001 (Goa Act No. 36 of 2001) so as to further amend the Goa Co-operative Societies Rules, 2003 are hereby pre-published as required by sub-section (3) of section 127 of the said Act

for information of all persons likely to be affected thereby and notice is hereby given that the said draft Rules will be taken into consideration by the Government after expiry of a period of 30 days from the date of publication of this Notification in the Official Gazette.

All objections and/or suggestions to the said draft Rules may be forwarded to the Registrar of Co-operative Societies and ex officio Joint Secretary to the Government of Goa, Co-operation Department, 4th floor, "Sah+akar Sankul", EDC Complex, Patto, Panaji-Goa, before the expiry of the said period of 30 days so that they may be taken into consideration at the time of finalization of the said draft Rules.

## DRAFT RULES

In exercise of the powers conferred by sub-sections (1) and (2) of section 127 of the Goa Co-operative Societies Act, 2001 (Goa Act No. 36 of 2001) and all other powers enabling it in this behalf, the Government of Goa hereby makes the following rules so as to further amend the Goa Co-operative Societies Rules, 2003, namely:—

1. *Short title and commencement.*— (1) These rules may be called the Goa Co-operative Societies (Amendment) Rules, 2021.

(2) They shall come into force at once.

2. *Amendment to Rule 4.*— In rule 4 of the Goa Co-operative Societies Rules, 2003, in sub-rule (4), for the expression “by registered post or delivery by hand”, the expression “by registered post or delivery by hand or through electronic means” shall be substituted.

Considering the sudden surge of COVID-19 cases in the State of Goa, and in order to make private services more affordable to the common man during the COVID 19 crisis, Government hereby reduces the capped rates prescribed vide order read above for COVID-19 patients in Private hospitals with ICU facilities as under:—

\* Admission charges, Intensivist, Primary and Specialist Consultant charges, Bed charges, nursing, Resident Doctor, diet, PPE kits for staff, X-Ray, ECG, USG, 2D Echo, Cardiac Monitor, Infusion Pump, Catheterization, CBC, FBSL, PPBSL, HBA1c, Creatinine, liver function test, blood group, routine medicine including multivitamin, Vitamin C, Zinc, Vitamin D, Paracetamol, Antacid, Anti-allergic, HCO, Azithromycin, Doxycycline, levofloxacin and dexamethasone, ivermectin, dietary charges.

*The above Package does not include:—*

- \* Diagnostic Interventions
- \* Special drugs
- \* Use of special equipment
- \* Other special procedures/surgery etc.
- \* Extra Oxygen flow other than ICU

8-4/PCE-PWD-Accts/2021-22/06

In exercise of the powers conferred by section 12 of the Goa Sewerage System and Sanitation Services Management Act, 2008 (Goa Act 14 of 2009), the Government of Goa hereby makes the following rules so as to amend the Goa Sewerage System and Sanitation Services Management Rules, 2010, namely:—

1. *Short title and commencement.*— (1) These rules may be called the Goa Sewerage System and Sanitation Services Management (First Amendment) Rules, 2019.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. *Amendment of rule 10.*— In rule 10 of the Goa Sewerage System and Sanitation Services Management Rules, 2010 for sub-rule 5, the following sub-rule shall be substituted, namely:—

“(5) As soon as sewerage facility is made available in the area/locality a public notice shall be issued in the local newspaper and also notice shall be served on consumer, stating that sewerage facility has been developed in that area by Government and that every person occupying a premises within 100 mts. radial distance from such sewerage facility shall avail house sewer connection within a period of two months from the date of issue of such notice, failing which, a penalty at the rate of 25% of water consumption charges shall be leviable on defaulting occupier for a initial period of six months and at the rate of 50% of such charges for further period of one year and thereafter the essential services such as water supply and electricity shall be liable for disconnection”.

mandatory sewer connections to be provided wherever sewerage facility is made available by the Government in view of the Notification No. 8-4/PCE-PWD-Accts/2021-22/06 dated 23-04-2021.
