Sealed Item Rate quotations are invited from the eligible bidders for the work of **“Electrical and networking works for installation of Justice Clock at High Court of Bombay at Goa, Penha - de - France, Porvorim, Goa (2nd Call)”**

The sealed quotations shall be received **upto 15:00 hours on 30th August 2022** and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is **Rs. 41,732.80**

The Schedule of Quantities including the description of the item is furnished in **ANNEXURE-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **ANNEXURE-I** while submitting the quotation. Rates shall be exclusive of GST. All the pages of **ANNEXURE-I** shall be duly stamped and signed. The list of approved brands and detailed technical specifications are furnished in **ANNEXURE-III**. The layout is furnished in **ANNEXURE-IV**.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs. 850.00** (Rupees Eight Hundred and Fifty only) in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.
