2. To examine the issues of the tribal communities and recommend intervention based research studies addressing the issues of the community.
3. To recommend the proposals to conduct Ethnographic study of the Tribal Communities of Goa.

4. To review the performance of the Implementing Departments.
5. To ensure submission of Utilization Certificate to the Ministry of Tribal Affairs, New Delhi in a time bound manner.

No. 36/1/TCP/426/2022/2097

Whereas, the Chief Town Planner (Planning) vide Order No. 36/1/TCP/322/2018/2628 dated 28-12-2018 conveyed directions of the Government under Section 39 of the Goa Town and Country Planning Act, 1974 (Act No. 21 of 1975) (hereinafter referred to as the "said Act"), to the North Goa Planning and Development Authority to take up the process afresh of revising the Outline Development Plan for Mapusa Planning Area by following the procedure envisaged under Sections 29, 30 and 34 to 37 of the said Act;

And whereas, the Chief Town Planner (Planning) vide another Order No. 36/1/TCP/327/2018/656 dated 15-03-2021 conveyed directions of the Government under Section 39(1) of the said Act, to the South Goa Planning and Development Authority to prepare the Outline Development Plans for Margao Planning Area and Ponda Planning Area and further directions that the provisions of Sections 34 to 38 (both inclusive) of the said Act shall apply;

And whereas, in pursuance of the said directions of the Government as conveyed vide said Orders, the North Goa Planning and Development Authority and the South Goa Planning and Development Authority had undertaken the process of preparation of their respective Outline Development Plans;

And whereas, the Government vide Order No. 47/5/TCP/2022-23/1026 dated 27-04-2022, published in the Official Gazette, Series II No. 4 dated 28-04-2022, inter alia directed the North Goa Planning and Development Authority and the South Goa Planning and Development Authority to keep on hold their respective draft Outline Development Plans and further directed them to prepare fresh Outline Development Plans for their respective planning

areas in consultation with the consultants/experts as may be decided by the Government and the Goa Town and Country Planning Board;

And whereas, the Goa Town and Country Planning Board in its 182nd meeting held on 01-08-2022 has decided that the Mapusa, Margao and Ponda Outline Development Plans shall now be prepared by the concerned Planning and Development Authorities as per the provisions prescribed under the said Act;

And whereas, the Government has approved the said decision of the Goa Town and Country Planning Board;

Now, therefore, in exercise of the power conferred by sub-section(1) of Section 132 of the Goa Town and Country Planning Act, 1974 (Act No. 21 of 1975) and in partial modification of the Government Order No. 47/5/TCP/2022-23/1026 dated 27-04-2022, published in the Official Gazette, Series II No. 4 dated 28-4-2022, the Government of Goa hereby directs that,

- (i) the North Goa Planning and Development Authority and the South Goa Planning and Development Authority shall prepare their respective Outline Development Plans as per the earlier directions of the Government as conveyed by the Chief Town Planner (Planning) vide said Order No. 36/1/TCP/322/2018/2628 dated 28-12-2018 and Order No. 36/1/TCP/327/2018/656 dated 15-03-2021 and in consultation with the consultants/experts as may be decided by the Government and the Goa Town and Country Planning Board;
- (ii) the areas such as low lying paddy fields, water bodies, khazan lands, flood prone areas, land having slopes more than 25%, forest land including private forest land, land falling in the buffer zone of Wild Life Sanctuaries and tenanted agricultural lands shall not be considered for change of zone during the preparation of the said Outline Development Plans;
- (iii) the process of preparation of Outline Development Plans by the aforesaid Planning and Development Authorities shall be completed within a period of 60 days from the date of commencement of this Order.

This Order shall come into force on the date of its publication in the Official Gazette.
